GEOGRAPHICAL NAMES ACT 1966

PURSUANT to the provisions of Section 10 of the *Geographical Names Act 1966*, the Geographical Names Board has this day assigned the names listed here under as geographical names.

Julia Reserve for a reserve located on the corner of Peter Brock Drive and South Circuit, in the suburb of Oran Park, Camden LGA.

Kolombo Reserve for a reserve located on the corner of Oran Park Drive and South Circuit, in the suburb of Oran Park, Camden LGA.

Brooking Park for a reserve located approximately 550m north-west of the Dransfield Drive and Brahma Street Intersection, in the suburb of Oran Park, Camden LGA.

Biddy Giles Park for a reserve located on the corner of Flora Street and Oak Road, in the suburb of Kirrawee, Sutherland Shire LGA.

Bubara View Park for a reserve bounded by Crest Road and Upland Chase in the suburb of Albion Park, Shellharbour LGA.
