REGULATION OF VESSELS – EXCLUSION ZONE

Location

Jervis Bay – near the township of Huskisson and the landmark of Shark Net Beach, between the southern side of Currambene Creek entrance and Tapalla Point then extending 500 metres into Jervis Bay to the unnamed island.

Duration

- 5:00pm to 6:30pm Friday 26 February 2021
- 6:00am to 3:00pm Saturday 27 February 2021
- 6:00am to 11:00am Sunday 28 February 2021

Detail

The swimming legs of various triathlon races and ocean swims will be conducted on the waters of Jervis Bay at the location specified above.

An **EXCLUSION ZONE** is specified during the event and will be indicated by the presence of course rounding buoys with the zone extending for 50 metres outside the course rounding buoys on all sides. The exclusion zone will be patrolled by Maritime vessels and event control vessels.

Unauthorised vessels and persons are strictly prohibited from entering the exclusion zone during the event.

REGULATION OF VESSELS – EXCLUSION ZONE AND SPECIAL RESTRICTIONS

Location

Murrumbidgee River – near Wagga Wagga, Oura Reserve and downstream to the Wagga Wagga Beach (at Cabarita Reserve)

Duration

9:30am to 2:00pm – Saturday 20 February 2021

Detail

A canoe and kayak event will be conducted on the waters of the Murrumbidgee River, at the location specified above.

An **EXCLUSION ZONE** is specified during the event which will be marked by the presence of control vessels.

Special Restrictions

Due to the risk to safe navigation and the nature and number of participating vessels, a Regulated Area will be created within which **Special Restrictions** will be imposed. The Regulated Area will comprise the full width of the Murrumbidgee River, and will move with the competing vessels as they travel the course, extending 200 metres ahead and 200 metres to the stern of the participants.

Pursuant to Section 12(3) of the *Marine Safety Act 1998*, special restrictions are applicable to **powered vessels** operating in the Regulated Area:

- Maximum speed limit of 4 knots, and
- Minimal wash must be produced.

Manning River, Taree - between Martin Bridge and Dumaresq Island

Detail

A number of jet powered vessel trials will be conducted on the waters of the Manning River, as specified above. The event will involve the use of powered vessels operating at speed - presenting a significant potential hazard to other waterway users.

An **EXCLUSION ZONE** is specified during the event at the above location which will be indicated by the presence of control vessels.

Unauthorised vessels and persons are strictly prohibited from entering the exclusion zone which will be monitored and patrolled by control vessels.

Provision has been made for vessels to transit the Zone during breaks in the trials. Control vessels may, at times during the trials, authorise vessel traffic to pass through the Zone.
