Direction under section 7 of the State Insurance and Care Governance Act 2015

In my capacity as the NSW Minister responsible for the *State Insurance and Care Governance Act 2015* and after reviewing the response from the Insurance and Care NSW Board, I formally direct that the Nominal Insurer premium filing for the financial year 2022/23 be limited to an average increase of 2.9 per cent.

This direction is made in the public interest to ensure the short term affordability of workers compensation by moderating the increase in premiums in 2022/23. In particular consideration has been given to the current impact on NSW businesses arising from two years of the COVID-19 pandemic and recent natural disasters such as the NSW East Coast floods.

Once the community has had time to recover from these significant events the affordability of premiums can be further considered. I encourage the Board to continue its focus on improving the financial performance of the Nominal Insurer.

IT is hereby notified, for general information, that Her Excellency the Governor has, in the name and on behalf of Her Majesty, this day assented to the undermentioned Acts passed by the Legislative Council and Legislative Assembly of New South Wales in Parliament assembled, viz.:

Act No. 14, 2022 - An Act to provide for the protection of persons who make public interest disclosures and for making and dealing with the disclosures; to repeal the *Public Interest Disclosures Act 1994* and the *Public Interest Disclosures Regulation 2011*; to make related amendments to certain legislation; and for related purposes. [Public Interest Disclosures Act 2022]

Act No. 15, 2022 - An Act to amend the Constitution Act 1902 to enable members of Parliament to attend meetings of Houses of Parliament remotely. [Constitution Amendment (Virtual Attendance) Act 2022]
