Order

Central Coast Council Area

Declaration as Controlled Access Road and repeal as Controlled Access Road,
of parts of the Central Coast Highway at West Gosford

I, the Minister for Regional Transport and Roads, by this order:

1. repeal the parts of the order published in Government Gazette No 94 of 4 June 2004 on page 3472:
 - a. which declared the main road described in Schedules 2 and 3 of that declaration to be controlled access road; and
 - b. which declared the public road described in Schedules 2 and 3 of that declaration to be main road;but only in so far as these parts pertain to the land described in Schedule 1 hereunder; and
2. pursuant to Sections 46, 49, 54 and 67 of the *Roads Act, 1993*:
 - a. dedicate as public road the land described in Schedules 2 and 3 under;
 - b. declare to be a main road the said public road described in Schedules 3 and 4 under;
 - c. declare to be a controlled access road the said main road described in Schedules 3 and 4 under;
 - d. declare that access to the said controlled access road is restricted; and
 - e. specify in Schedule 5 under, the points along the controlled access road at which access may be gained to or from other public roads.
