SCHEDULE "C"

1. All works to the public toilet structure on Faulkner Street, Armidale (excluding the expansion of the existing footprint or height of the public toilet structure).
2. All works to the bus shelter structure on Faulkner Street, Armidale (including removal of the structure) but excluding the expansion of the existing footprint of the bus shelter structure.
3. All works to maintain and conserve the monument at the corner of Beardy and Faulkner Streets, Armidale (excluding removal of the monument structure).
