

Detail

The Vivid Paramount+ Drone show event will take place at the location on one of the days specified above (weather or other factors dependent). A barge will be used as a launch and landing location for the drones, accompanied by a support craft.

Exclusion Zone

An **Exclusion Zone** will be established across the mouth of Sydney Cove from the Port Lateral Mark off the Sydney Opera House Seawall to the Port Lateral Mark off Dawes Point. On whichever day the event occurs, the Exclusion Zone will be indicated by the presence of Maritime patrol vessels displaying emergency lights along the perimeter.

Maritime vessels will communicate the activation and deactivation of the Exclusion Zone over VHF 13 to Sydney VTS.

Unauthorised vessels and persons are strictly prohibited from entering the Exclusion Zone.

Penalties may apply (section 12(5) - Marine Safety Act 1998)



Location

Sydney Harbour - Kirribilli and Sydney Cove

Duration

5:30pm to 6:30 pm on Friday 27 May 2022

Detail

In support of the opening night of Vivid Sydney 2022, fireworks will be deployed from a barge near Jeffrey St Wharf, Kirribilli. The area around the barge may be dangerous to other vessels and persons.

Exclusion Zones

An Exclusion Zone will be established, indicated by the presence of Maritime patrol vessels around the perimeter of the fireworks exclusion zones, as depicted in the diagrams provided. The Exclusion Zones will be collapsed in turn by the Maritime patrol vessels moving away from the areas and turning off their emergency lights.

Maritime vessels will communicate the activation and deactivation of the Exclusion Zone over VHF 13 to Sydney VTS.

Unauthorised vessels and persons are strictly prohibited from entering the Exclusion Zone.

Penalties may apply (section 12(5) - Marine Safety Act 1998)



REGULATION OF VESSELS – EXCLUSION ZONE

Location

Kiama Harbour, Tasman Sea – within a 100 metre radius of the Kiama Helipad located at the north eastern extremity of the Kiama Boat Harbour

Duration

5.30pm - 9.30pm - Saturday 4 June 2022

Detail

A fireworks display will be conducted over the navigable waters of Kiama Harbour and the adjacent waters of the Tasman Sea specified above. The display will be staged from land at the above location. The area directly around this location may be dangerous and hazardous while the fireworks are being launched.

An **EXCLUSION ZONE** is specified during the event, extending for a radius of 70 metres around the display. The Zone will be monitored and maintained by event staff.

Unauthorised vessels (i.e. vessels that are not already lawfully moored in the zone) and persons are strictly prohibited from entering the Zone or operating vessels inside the Zone.

Vessels moored within the area must remain at their position and MUST NOT be operated during the event.
