REGULATION OF VESSELS - EXCLUSION ZONE

Location

Nepean River, Penrith - all waters within an area from Penrith Weir to 10kms south (upstream) in the Nepean Gorge.

Duration

10.00am to 2.00pm - Sunday 19 June 2022

Detail

A kayak event will be conducted on the navigable waters of the Nepean River as described above.

An **EXCLUSION ZONE** is specified during the event on the date and time above and will comprise the entirety of the width of the river.

Unauthorised vessels and persons are strictly prohibited from entering the Exclusion Zone, which will be monitored by control vessels at the perimeter.

Penalties may apply (section 12(5) - Marine Safety Act 1998).
