SUBORDINATE LEGISLATION ACT 1989

Proposed Conveyancing (Sale of Land) Regulation 2022

The proposed *Conveyancing (Sale of Land) Regulation 2022* will remake the *Conveyancing (Sale of Land) Regulation 2017* with minor changes.

The proposed Regulation supports the *Conveyancing Act 1919 (NSW)* by providing for a vendor disclosure regime that facilitates the early exchange of contracts and reduces the opportunity for gazumping. The Regulation provides the detail of the regime that requires vendors to make certain warranties in, and attach prescribed documents to, contracts for the sale of land relating to issues of title and the property's use. The Regulation also provides remedies for purchasers who enter a contract relying on the prescribed documents and the vendor's warranties.

A Regulatory Impact Statement (RIS) has been prepared examining the need for the regulation and its costs and benefits. The RIS accompanies a consultation draft of the Regulation. 1. Citation

This Order may be cited as the Infrastructure NSW Sydney Football Stadium Project Divesting Order 2022.

2. Effective Date
