Anti-Discrimination Act 1977

EXEMPTION ORDER

Under the provisions of section 126 of the *Anti-Discrimination Act* 1977 (NSW), an exemption is given from sections 8 and 51 of the *Anti-Discrimination Act* 1977 (NSW) to the Qantas Group and its subsidiaries to advertise, designate and recruit roles for Aboriginal and Torres Strait Islander persons only in pursuance of a 3% Aboriginal and Torres Strait Islander workforce participation rate.

This exemption will remain in force for 10 years.

1. Order of 23 March 2018 varied to read:

Under the provisions of section 126 of the *Anti-Discrimination Act 1977* (NSW), an exemption is given from sections 25 and 51 of the *Anti-Discrimination Act 1977* (NSW) to TPG Telecom Limited to introduce initiatives to improve the representation of women at senior leadership level.

This exemption will remain in force until 22 March 2023.

2. Order of 14 April 2016 varied to read:

Under the provisions of section 126 of the *Anti-Discrimination Act* 1977 (NSW), an exemption is given from sections 25 and 51 of the *Anti-Discrimination Act* 1977 (NSW) to TPG Telecom Limited to provide additional superannuation contributions to its permanent full-time, permanent part-time and casual female employees in NSW.

This exemption will remain in force until 13 April 2026.
