CHARITABLE TRUSTS ACT 1993 NOTICE UNDER SECTION 15 CY PRES SCHEME RELATING TO THE ESTATE OF THE LATE GAIL LEONARD

Section 12(1)(a) of the *Charitable Trusts Act 1993* permits the Attorney General to establish a cy pres scheme to alter the original purpose of a charitable trust. Section 9(1) permits the application of trust property cy pres where the spirit of the original trust can no longer be implemented.

Under clause 5 of the Will of the late Gail Leonard, dated 11 September 2014, Ms Leonard made a bequest to the Leopold Wildlife Shelter for its general purposes. The value of the gift is less than \$84,000.

The Leopold Wildlife Shelter provided an emergency response service to rescue and rehabilitate orphaned and injured wildlife in regional Victoria. The gift under the Will cannot be applied to the Leopold Wildlife Shelter as it does not have a legal identity, with the business registration being a partnership between David and Helen Burrell, who are now both deceased. It also appears to have ceased operating on or about 12 August 2017, upon the death of Helen Burrell.

The bequest to the Leopold Wildlife Shelter is considered to have created a charitable trust, as the provision of wildlife emergency response services falls within the charitable purpose of the protection and preservation of native wildlife. Further, gifts for the 'general purposes' of a charitable organisation are gifts for charitable purposes.

NSW Wildlife Information Rescue and Education Service (ABN 30768872928) (WIRES) has been identified as having a similar charitable purpose and providing the same services as the Leopold Wildlife Shelter. WIRES is Australia's largest wildlife rescue organisation and has been operating for over 35 years. Its objects include wildlife rescue, preservation and rehabilitation, information, education and training and protection and conversation for native wildlife in Australia. WIRES is registered as a charity with the Australian Charities and Not-for-profits Commission.

The executor of the estate has no objection to a cy pres scheme applying the funds to WIRES.

In circumstances where the gift in clause 5 of the Will cannot be applied to the Leopold Wildlife Shelter, as it has ceased to exist, the Solicitor General, as the Attorney General's delegate, has approved the establishment of a cy pres scheme so that the gift to the Leopold Wildlife Shelter is to be paid to WIRES for its charitable purposes.

Take note that within one month after the publication of this notice any person may make representations or suggestions to the Attorney General in respect of the proposed scheme.

EXEMPTION ORDER
