Manning River, Taree - adjacent to Queen Elizabeth Park, between the Martin Bridge and Endeavour Place Boat ramp

Duration

7.00am to 4.30pm on the following dates:

- Saturday 10 September 2022
- Sunday 11 September 2022

Detail

Dragon Boat Races will be conducted on the navigable waters of the Manning River, at the dates and times specified above.

An **EXCLUSION ZONE** is specified during the event at the above location. The area will consist of a 200 metre course and will be marked by buoys and patrolled by control vessels.

Unauthorised vessels and persons are strictly prohibited from entering the Exclusion Zone during the times above.

Penalties may apply (Section 12(5) - Marine Safety Act 1998).

Transit Lane

Provision may be made (where necessary) for a control vessel to authorise local vessel traffic to pass safely through the Exclusion Zone via a 'transit lane'.

REGULATION OF VESSELS – EXCLUSION ZONE

Location

Manning River - between the Martin Bridge at Taree, along the Manning River South Passage, to Ghinni Ghinni Creek

Duration

8.30am to 5.00pm on the following dates:

Saturday 17 and Sunday 18 September 2022

Detail

Competitive water ski races will be conducted on the navigable waters of the Manning River at the times specified above, involving the use of high speed power vessels, persons being towed at speed using towlines, and persons in the water from time to time presenting a significant potential hazard to other waterway users.

An **EXCLUSION ZONE** is specified during the event which will be indicated by the presence of support vessels on the perimeters. The Exclusion Zone will also be monitored by control vessels.

Unauthorised vessels and persons are strictly prohibited from entering the Exclusion Zone.

Penalties may apply (section 12(5) - Marine Safety Act 1998)

Transiting vessels

Provision will be made for vessels to transit the Exclusion Zone during breaks in racing. Control vessels will, at times during the events, indicate a temporary lifting of the Exclusion Zone to allow local vessel traffic to cross. Vessel crossing at these times will not be in breach of the Exclusion Zone.
