ORDER UNDER SECTION 5 OF THE MOTOR SPORTS EVENTS ACT 2022

Order Regarding Motor Vehicle Racing at Mount Panorama


I, the Alister Henskens, SC MP, Minister for Sport, pursuant to section 5 of the *Motor Sports Events Act 2022*, having taken advice from the Office of Sport and consulted with Bathurst Regional Council, and having considered public submissions, do by this Order, effective at the time of publication in the New South Wales Government Gazette:

- State that Bathurst Regional Council is the entity entitled to apply for a motor race authorisation to conduct motor racing at Mount Panorama at Bathurst, pursuant to s5(1)(c)(i);
- 2. Declare the event area pursuant to s5(1)(a) to be as set out in Schedule 1 of this Order;
- 3. Declare the event period pursuant to s5(1)(b) to be:
 - a. Bathurst 1000 06-09 October 2022;
 - b. Bathurst International 11-13 November 2022;
 - c. Challenge Bathurst 24 November 2022 to 01 December 2022;
 - d. Bathurst 12 Hour 03-09 February 2023; and
 - e. Bathurst 6 Hour 07-10 April 2023.
- Require pursuant to s5(1)(d) that Bathurst Regional Council make any such application(s) in writing to the Office of Sport by the time requested and using the application form approved by the Executive Director, Policy and Planning, Office of Sport;
- 5. Specify that the Office of Sport is the government coordinating agency for the purpose of s5(1)(e)(e).

Shoalhaven Starches Pty Limited (ABN 94 000 045 045:), having its registered office at 36 Bolong Road, Bornaderry NSW 2541, has applied, in accordance with the provisions of section 13 of the *Pipelines Act 1967* (hereinafter called "the Act") and Pipelines Regulation 2013 (hereinafter called "the Regulation"), for a Licence to operate a pipeline (heinafter called Licence No. 40) to convey natural gas between at Meroo Meadow and Bornaderry has agreed at Annexure A to accept the Licence and the provisions and conditions attached thereto.

This application complies with the provisions of the Act and Regulation and therefore I, Matt Kean; Minister for Energy, do grant Licence No. 40 to Shoalhaven Starches Limited, effective from my signing of this Licence.

NOTIFICATION OF VESTING OF EASEMENTS OVER LANDS

PIPELINE LICENCE NO. 40

I, Matt Kean, Minister for Energy, pursuant to Sections 21 and 61 of the Pipelines Act 1967, hereby declare:

- 1. that the easements over lands described in Schedule 1 are vested in Shoalhaven Starches Pty Limited (ABN 94 000 045 045), for the purposes of, and incidental to, the construction and operation of Pipeline Licence No.40; and
- 2. the restrictions as to user set out in Schedule 2 have effect in respect of the lands described in Schedule 1.

SCHEDULE 1

EASEMENTS FOR PIPELINE TO BE VESTED IN THE LICENSEE

Easement over pieces or parcels of land as described in Deposited Plan (DP) 1284407, except part 'A' within Lot 8302 DP 1150373, as lodged and registered with NSW Land Registry Services.

SCHEDULE 2

RESTRICTIONS AS TO USER

Without affecting the generality of any requirement imposed by the *Pipelines Act 1967* or *Pipelines Regulation 2013*, the owner or occupier of land over which there is an easement for pipeline must not within the easement, except with the prior consent in writing of the person in whom the easement is vested:

- (a) Excavate (including blasting), drill or dig.
- (b) Erect, place or permit to be erected or placed any building, structure (including fence posts), plant, apparatus or equipment, earthworks, utility services or other improvements whether permanent or temporary on, over or under the land.
- (c) Alter or disturb existing levels, contours or gradients.
- (d) Plant or cultivate any tree within 3 metres of the pipeline or any apparatus or works.
- (e) Place on or use any part of the servient tenement for the transport, carriage or support of any heavy object, vehicle or implement, which could in any way cause or be likely to cause damage to the pipeline.
- (f) Undertake any other activity that represents a danger to the pipeline or is a danger to the operation of the pipeline or its apparatus or works including signs, vent pipes and cathodic protection systems including anode beds and electrolysis test points.
