Anti-Discrimination Act 1977

EXEMPTION ORDER

Under the provisions of section 126 of the *Anti-Discrimination Act 1977* (NSW), an exemption is given from sections 49D and 51 of the *Anti-Discrimination Act 1977* (NSW) to The Hills Shire Council to advertise, designate and recruit up to 4 people who self- identify as having an intellectual disability for Library Shelver positions.

This exemption will remain in force for 10 years.
