#### ORDER

### Withdrawal of Drug Authority

In accordance with the provisions of clause 175(1) of the *Poisons and Therapeutic Goods Regulation 2008* an Order has been made on **Mrs Margaret Rose Lewis (PHA0001946765)**, of Merewether NSW 2291, prohibiting her, until further notice, as a pharmacist, from supplying or having possession of, or manufacturing any preparation, admixture, or extract of a drug of addiction as authorised by clauses 85, 99, 99A, 101(1) and 102 of the Regulation.

This Order is to take effect on and from 7 October 2022.

### Restoration of Drug Authority

In accordance with the provisions of clause 175(1) of the *Poisons and Therapeutic Goods Regulation 2008* a direction has been issued that the Order that took effect on and from 9 October 2019, on **Dr David Nabil Lewis Daoud (MED0002031049)** of WOY WOY NSW 2256, prohibiting him as a medical practitioner, from supplying, having possession of or issuing a prescription for a drug of addiction as authorised by clauses 101 and 77 of the Regulation, shall cease to operate on and from 12 October 2022.
