MENTAL HEALTH ACT 2007 Section 109 Declaration of Mental Health Facility

- I, **BRENDAN FLYNN**, Acting Executive Director, Mental Health Branch, acting under delegation from the Secretary, NSW Ministry of Health, and pursuant to section 109 of the *Mental Health Act 2007*, DO HEREBY:
- (a) DECLARE the following premises of **St Vincent's Hospital, 390 Victoria Street, Darlinghurst NSW 2010** to be a declared mental health facility for the purposes of section 109 of the *Mental Health Act 2007:*
 - St Vincent's Hospital Sydney Psychiatric and Non-Prescribed Drug Assessment (PANDA) Unit, Level 3 (Ground Floor), Aikenhead Building, off Victoria Street; and
- (b) DECLARE this facility to be designated as a "mental health emergency assessment class" facility; and
- (c) RESTRICT this facility to the provision of acute assessment functions, where a patient can be held in anticipation of discharge should their clinical condition resolve rapidly, or transferred to a declared mental health facility of the "mental health assessment and inpatient treatment" class if required, in accordance with all provisions of the *Mental Health Act 2007*, with the exception of:
- i. Chapter 2;
- ii. Division 3 of Part 2 of Chapter 3;
- iii. Division 1 of Part 3 of Chapter 3;
- iv. Sections 57 and 58 of Division 2 of Part 3 of Chapter 3.

MENTAL HEALTH ACT 2007 Section 109 Declaration of mental health facility

- **I, BRENDAN FLYNN,** Acting Executive Director, Mental Health Branch, acting under delegation from the Secretary, NSW Ministry of Health, and pursuant to section 109 of the *Mental Health Act 2007* and section 43 of the *Interpretation Act 1987*, DO HEREBY:
- (a) **REVOKE** the Order published in the NSW Government Gazette No. 105 of 28 May 2020 (n2020-1484), declaring certain inpatient units of St Vincent's Hospital, Darlinghurst, to be a declared mental health facility for the purposes of section 109 of the *Mental Health Act 2007*; and
- (b) **DECLARE** the following mental health units on the **St Vincent's Hospital campus**, located at 390 Victoria Street, Darlinghurst NSW 2010 to be a declared mental health facility for the purposes of section 109 the *Mental Health Act 2007*:
 - St Vincent's Hospital Sydney Psychiatric Emergency Care Centre (PECC) Unit, Level 3 (Ground Floor), Aikenhead Building, off Victoria Street, Darlinghurst;
 - The Caritas Centre, located on Level 5 of the O'Brien Centre, off Burton Street; and
- (c) DECLARE this facility to be designated as a "mental health assessment and inpatient treatment" facility.

ORDER

Restoration of Drug Authority

In accordance with the provisions of clause 175(1) of the *Poisons and Therapeutic Goods Regulation 2008* the Order that took effect on and from 31 July 2020 issued to **Dr Aleksandar Andric (MED0001400073)**

Withdrawal of Drug Authority
