

LEGISLATIVE ASSEMBLY

ACTS OF PARLIAMENT ASSENTED TO Legislative Assembly Office, Sydney 18 October 2022

It is hereby notified, for general information, that Her Excellency the Governor, has, in the name and on behalf of His Majesty, this day assented to the under mentioned Acts passed by the Legislative Assembly and Legislative Council of New South Wales in Parliament assembled, viz.:

Act No. 43 — An Act to amend the *Crimes (Administration of Sentences) Act 1999* to provide that a parole order must not be made for an offender serving a term of imprisonment for a homicide offence if the offender has not cooperated in locating the victim's body or remains. **[Crimes (Administration of Sentences) Amendment (No Body, No Parole) Bill]**

Act No. 44 — An Act to amend the *Crimes (Sentencing Procedure) Act 1999* to require a court, except in certain circumstances, to sentence an offender in accordance with the sentencing patterns and practices at the time of sentencing and to clarify that intensive correction orders are not available in relation to certain historical sexual offences. **[Crimes (Sentencing Procedure) Amendment Bill]**

Act No. 45 — An Act to amend the *Crimes Act 1900* to create new offences relating to money laundering; and to make related amendments. **[Crimes Amendment (Money Laundering) Bill]**

Act No. 46 — An Act to establish a scheme for dedicated encrypted criminal communication device prohibition orders; to create a new offence in the *Crimes Act 1900* in relation to possessing a dedicated encrypted criminal communication device to commit or facilitate serious criminal activity; and to make consequential amendments to other legislation. **[Dedicated Encrypted Criminal Communication Device Prohibition Orders Bill]**

Act No. 47 — An Act to amend the *Law Enforcement (Powers and Responsibilities) Act 2002* to provide for digital evidence access orders; and for related purposes. **[Law Enforcement (Powers and Responsibilities) Amendment (Digital Evidence Access Orders) Bill]**

Act No. 48 — An Act to amend the *Crimes Act 1900* to create new offences in relation to assaults on, and other actions in relation to, law enforcement officers and frontline emergency and health workers and persons who come to the aid of law enforcement officers; to amend the *Criminal Procedure Act 1986* to provide for the new offences in the *Crimes Act 1900* to be triable summarily; and for related purposes. **[Crimes Legislation Amendment (Assaults on Frontline Emergency and Health Workers) Bill]**

Act No. 49 — An Act to make amendments to certain legislation about the procedure for the prosecution of indictable offences. **[Criminal Procedure Legislation Amendment (Prosecution of Indictable Offences) Bill]**

Act No. 50 — An Act to amend the *Royal Botanic Gardens and Domain Trust Act 1980* to provide power for the acquisition by Sydney Metro of substratum of Trust lands for underground rail facilities in relation to the Sydney Metro West. **[Royal Botanic Gardens and Domain Trust Amendment (Facilitation of Sydney Metro West) Bill]**

Act No. 51 — An Act to make miscellaneous amendments to the *Scrap Metal Industry Act 2016* and the *Scrap Metal Industry Regulation 2016* following a statutory review of the Act. **[Scrap Metal Industry Amendment (Review) Bill]**

Act No. 52 — An Act to make miscellaneous amendments to the *Security Industry Act 1997* and the *Security Industry Regulation 2016*; and to include new offences in the *Tattoo Parlours Act 2012*. **[Security Industry Amendment Bill]**

Act No. 53 — An Act to amend the *Workers' Compensation (Dust Diseases) Act 1942* and the *Workers Compensation Act 1987* to make further provision about rates of compensation payable to workers; and for related purposes. **[Workers' Compensation (Dust Diseases) Amendment Bill]**
