Commencement of Manning River Estuary Coastal Management Program 2022

Notice is given under Section 17(4) of the Coastal Management Act 2016, that upon the publication of this Notice in this Gazette, the Manning River Estuary Coastal Management Program 2022 will commence.

MidCoast Council has prepared the Manning River Estuary Coastal Management Program 2022 (CMP) and received certification by the Minister for the Local Government under Section 17(2) of the Coastal Management Act 2016. The CMP presents a long-term plan for the management of the Manning River Estuary to deliver sustainable environmental, social and economic benefits for the Coastal Zone of the Manning estuary commencing 2 km inland from the open coast. It provides an iterative program of adaptable risk mitigation actions that are feasible, viable and acceptable for the community and MidCoast Council.
