REGULATION OF VESSELS – EXCLUSION ZONE & SPECIAL RESTRICTIONS

Location

Hunter River, Raymond Terrace – entire width of the river downstream from the Fitzgerald Bridge, between the prolongations of Bourke Street and Swan Street

Duration

9.00am to 5.00pm on the following dates:

- Saturday 29 and Sunday 30 October 2022
- Sunday 27 November 2022
- Saturday 11 and Sunday 12 February 2023
- Sunday 26 March 2023
- Sunday 21 May 2023
- Saturday 19 and Sunday 20 August 2023

Detail

A number of high-speed powerboat races will be conducted on the navigable waters of Hunter River, Raymond Terrace specified above.

An **EXCLUSION ZONE** is specified during the event, which will be indicated by control vessels stationed on the boundary.

Unauthorised vessels and persons are strictly prohibited from entering the Exclusion Zone.

Transit Arrangements and Special Restrictions

Provision may be made (where necessary) for a control vessel to authorise local vessel traffic to pass safely through the Exclusion Zone via a 'transit lane'. Pursuant to section 12(3) of the Act, vessels using the transit lane must do so at a speed not exceeding 4 knots and must produce minimal wash.

Penalties may apply (section 12(5) - Marine Safety Act 1998)

REGULATION OF VESSELS – EXCLUSION ZONE & SPECIAL RESTRICTIONS

Location

Shoalhaven River, Nowra – the entire width of the river from the Princes Highway Bridge extending 750m downstream to the landmark of Lyrebird Drive

Duration

• 11.00am to 10.00pm – Saturday 29 October 2022

Detail

A festival will be held on the navigable waters of Shoalhaven River specified above. A number of water activities will be conducted including wake boarding, wake surfing, and dragon boat/paddlecraft displays. The festival will involve active power vessels and the possibility of persons in the water from time to time, presenting a significant potential hazard to other waterway users.

An **EXCLUSION ZONE** is specified during the event which will be indicated by the presence of control vessels stationed on the perimeter. The Zone will be monitored by control vessels, Maritime, Water Police and Marine Rescue vessels.

Unauthorised vessels and persons are strictly prohibited from entering the Exclusion Zone.

Transit lane

Provision will be made for a 'transit lane', around the Zone within which a Maritime BSO via a control vessel will, at times during low-risk activities, authorize local vessel traffic to transit the Zone.

Special Restrictions

Pursuant to section 12(3) of the *Marine Safety Act 1998*, vessels navigating the transit lane must do so at a speed not exceeding 4 knots and must produce no wash.

Penalties may apply (section 12(5) - Marine Safety Act 1998)

Section 99B(4) of the Act provides that on closure of a level-crossing under that section all rights, easements and privileges in relation to that level-crossing are extinguished.

MINISTERIAL ORDER MADE UNDER SECTION 19

Ministerial (Electric and Hydrogen Vehicle Transit Lane Exemption) Order 2022

I, Natalie Ward, Minister for Metropolitan Roads, pursuant to section 19(1) of the *Road Transport Act 2013* (NSW), make the following Order.

1. Name of Order

This Order is the *Ministerial (Electric and Hydrogen Vehicles Transit Lane Exemption) Order 2022*

2. Commencement

This Order has effect on and from 1 November 2022 and remains in force up to and including 31 October 2023 unless revoked earlier.

3. Interpretation

Words and expressions used in this Order have the same meaning as in the *Road Transport Act 2013* unless otherwise stated.

4. Definitions

In this Order the following are defined:

battery electric vehicle means a motor vehicle that-

(a) uses only an electric motor for propulsion, and

- (b) is not fitted with-
 - (i) a fuel cell, or
 - (ii) an internal combustion engine.

hydrogen fuel cell electric vehicle means a motor vehicle that—

- (a) uses an electric motor for propulsion, and
- (b) is equipped with a fuel cell for converting hydrogen to electricity, and
- (c) is not fitted with an internal combustion engine.

5. Circumstances

This Order only applies to a driver of a **battery electric vehicle** or **hydrogen fuel cell electric vehicle** to which is affixed to the vehicle's number plate a label in accordance with clauses 144A or 144B of Schedule 2 of the Road Transport (Vehicle Registration) Regulation 2017.

6. Declaration

Road Rule 156 of the Road Rules 2014 is declared not to apply to drivers meeting the circumstances outlined in clause 5 of the Order.

7. Publication

The Order is to be published in the NSW Government Gazette.

Explanatory note:

The object of this Order is to allow drivers of battery electric and hydrogen fuel cell motor vehicles to be driven in Transit Lanes, regardless of the number of passengers in the vehicle, subject to meeting certain circumstances in the Order.

This Order is made under section 19 of the Road Transport Act 2013.

REGULATION OF VESSELS – EXCLUSION ZONE

Location Sydney Harbour – Farm Cove

Event Duration

2:00pm -4:00pm on Wednesday 2 November 2022

2:00pm – 4:00pm and 9:00pm – 10:00pm on Thursday 3 November 2022

Detail

A special event will take place on Sydney Harbour at the above location being a show where a swarm of drones will briefly hover at low level over Sydney Harbour displaying images using lights. Due to the potential to affect the safety of navigation, an Exclusion Zone will be established at the location specified above and in the map below.

Exclusion Zone

The Exclusion Zone will be established within Farm Cove from the northern seawall of the Sydney Opera House to the northern tip of Mrs Macquaries Point at the above times. The Exclusion Zone will only be activated for an appropriate timeframe within the above timeframes to safely enable the event.

NO UNAUTHORISED VESSELS are to enter the Exclusion Zone, which will be patrolled by Maritime vessels and monitored by other control vessels.

Any vessel operator entering the Exclusion Zone is liable to be guilty of an offence (*Marine Safety Act* 1998, s.12(5) - Maximum Penalty \$1,100.00)


