The New South Wales Government Gazette is the permanent public record of official NSW Government notices. It also contains local council, non-government and other notices.

Each notice in the Government Gazette has a unique reference number that appears in parentheses at the end of the notice and can be used as a reference for that notice (for example, (n2019-14)).

The Gazette is compiled by the Parliamentary Counsel's Office and published on the NSW legislation website (www.legislation.nsw.gov.au) under the authority of the NSW Government. The website contains a permanent archive of past Gazettes.

By Authority Government Printer [Note: The NSW Government Gazette is a permanent public record. As such, notices cannot be changed once gazettal has taken place. Erratum notices can figuratively correct an error but no tangible change can be made to the original notice.

The following is an example that should be adapted as required, with attention paid to the basic requirements of a Gazette erratum notice available in the <u>Frequently Asked Questions (FAQs) — for agencies</u>]

Section 162 of the Roads Act 1993

Naming of Roads – Change of road type from Mandalas Street to Mandalas Place and change the locality from Box Hill to Gables

ERRATUM

In the notice published in NSW Government Gazette No 89 of 18 August 2017, page/number 4493, the words "Mandalas Street" are replaced with "Mandalas Place" and the word "Box Hill" is replaced with "Gables". This notice corrects that error.
