MENTAL HEALTH ACT 2007 Section 109 Declaration of Mental Health Facility

- I, DR BRENDAN FLYNN, Acting Executive Director, Mental Health Branch, acting under delegation from the Secretary, NSW Ministry of Health, and pursuant to section 109 of the *Mental Health Act 2007*, DO HEREBY:
- (a) DECLARE the following premises of **Westmead Hospital**, Corner of Hawkesbury Road and Darcy Road, Westmead NSW 2145, to be a declared mental health facility for the purposes of the *Mental Health Act 2007*:
 - Mother and Baby Unit, located in Building D and Building E of the Redbank House Campus on Dragonfly Drive; and
- (b) DECLARE this facility in the "mental health assessment and inpatient treatment class" facility.

MENTAL HEALTH ACT 2007 Section 109 Declaration of Mental Health Facility

- I, DR BRENDAN FLYNN, Acting Executive Director, Mental Health Branch, acting under delegation from the Secretary, NSW Ministry of Health, and pursuant to section 109 of the *Mental Health Act 2007* and section 43 of the *Interpretation Act 1987*, DO HEREBY:
- a) REVOKE the Order published in the NSW Government Gazette No. 126 of 24 November 2017 page 7315, declaring the Acute Adolescent Unit of Redbank House at Westmead Hospital Campus to be a declared mental health facility in accordance with section 109 of the *Mental Health Act 2007*; and
- b) DECLARE the following premises of **Westmead Hospital**, Corner of Hawkesbury Road and Darcy Road, Westmead NSW 2145, to be a declared mental health facility for the purposes of section 109 of the *Mental Health Act 2007*:
 - Acute Adolescent Unit, located in Building H of the Redbank House Campus on Dragonfly Drive; and
- c) DECLARE this facility to be designated as a "mental health assessment and inpatient treatment" class facility.
