MENTAL HEALTH ACT 2007 Section 109 Declaration of mental health facility

- I, DAVID PEARCE, Executive Director, Mental Health Branch, acting under delegation from the Secretary, NSW Ministry of Health, and pursuant to section 109 of the *Mental Health Act 2007*, and section 43 of the *Interpretation Act 1987*, and to, in part, facilitate the transfer of patients from a current declared mental health unit, Bungarribee House, to alternate accommodation in Building B at Blacktown Hospital, **DO HEREBY**:
- (a) **REVOKE** the Order published in the NSW Government Gazette No. 117 of 4 October 2019 (n2019-3032), declaring Bungarribee House and the Melaleuca Unit of Blacktown Hospital, to be a declared mental health facility for the purposes of section 109 of the *Mental Health Act 2007*; and
- (b) **REVOKE** the Order published in the NSW Government Gazette No. 93 of 23 August 2019 (n2019-2492), declaring the Psychiatric Emergency Care Centre of Blacktown Hospital, to be a declared mental health facility for the purposes of section 109 of the *Mental Health Act 2007*; and
- (c) **DECLARE** the following premises of **Blacktown Hospital**, **Blacktown Road**, **Blacktown NSW 2148** to be a declared mental health facility for the purposes of section 109 the *Mental Health Act 2007*:
 - Bungarribee House, located at Building J (until 22 March 2022);
 - Melaleuca Unit, located at Building F;
 - Psychiatric Emergency Care Centre (PECC) located within the Emergency Department, Level 2, Building A;
 - Mental Health Inpatient Unit (B22), located on Level 2, Building B; and
- (d) DECLARE this facility to be designated as a "mental health assessment and inpatient treatment" facility.

POISONS AND THERAPEUTIC GOODS ACT 1966

ORDER ISSUED UNDER SECTION 34

SUPPLY OF REGULATED GOODS

Pursuant to section 34(3) of the Poisons and Therapeutic Goods Act 1966, I Dr Kerry Chant, Chief Health Officer, a duly appointed delegate for the Minister for Health do hereby exempt the supply of condoms at public events from the operation of s34(1) of the Poisons and Therapeutic Goods Act until 31 December 2024.

This Order is subject to the following conditions:

- a) The condoms are included in the Australian Register of Therapeutic Goods.
- b) The person supplying the condoms must notify the Ministry of Health of the intention to supply condoms at a public event no less than seven days prior to the public event occurring.
- c) The product must be offered only to persons at least aged 16 years of age.
- d) The product must be supplied only in the original packs (including batch numbers and expiry dates).
- e) The distribution must be carried out in a manner that enables the intended recipient to be fully aware that the product is being offered before accepting the pack.
