Jervis Bay and the adjacent coastal waters of the Tasman Sea.

Detail

The Australian Defence Force will be conducting vessel trials and exercises on the navigable waters of Jervis Bay and the adjacent coastal waters of the Tasman Sea at various times, including at night, on the dates specified above, presenting a significant potential hazard to other waterway users.

A number of **EXCLUSION ZONES** will be specified during the trials and exercises. Some Exclusion Zones may be mobile and may surround and move with participating vessels - in effect forming a moving ring around such vessels.

The Exclusion Zones will be indicated by the presence of patrol and naval vessels on the perimeters. Vessel operators navigating near Exclusion Zones will be directed to keep clear.

Unauthorised vessels and persons are strictly prohibited from entering the Exclusion Zones.

REGULATION OF VESSELS – EXCLUSION ZONE

Location

Tomaga River – Entire width of the river between the entrance to the estuary at Mossy Point, where the Tomaga River meets the Tasman Sea, upstream for approximately 2 kilometres to a point adjacent to the Tomakin Sports Club at Tomakin.

Duration

• 9.00am to 1.00pm – Saturday 25 March 2023

Detail

The swim leg of various triathlon races will be conducted on the navigable waters of the Tomaga River as specified above.

An **EXCLUSION ZONE** is specified during the event which will be indicated by the presence of large inflatable buoys and monitored and maintained by control vessels.

Unauthorised vessels and persons are prohibited from entering the Exclusion Zone.

REGULATION OF VESSELS - EXCLUSION ZONE AND SPECIAL RESTRICTIONS

Location

Clarence River, Maclean – between McLachlan Park and MacNaughton Place, approximately 1km downstream from the courthouse

Duration

• 9.00am to 4.00pm – Sunday 19 March 2023

Detail

Power boat and personal watercraft races will be conducted on the navigable waters of Clarence River, Maclean specified above.

An **EXCLUSION ZONE** for is specified during the event, which will be marked by buoys and monitored by Maritime and Police vessels

Unauthorised vessels and persons are strictly prohibited from entering the Exclusion Zone.

Transit lane

Provision may be made (where necessary) for a control vessel to authorise local vessel traffic to pass safely through the Exclusion Zone via a 'transit lane'.

Special Restrictions

Pursuant to section 12(3) of the Act, vessels using the transit lane must do so at a speed not exceeding 4 knots and must produce minimal wash

Section 99B Closure of level-crossings, bridges and other structures

Notice of Proposed Closure of Level-crossing 462.435 km on the Main South Rail Line.

Australian Rail Track Corporation ABN 75 081 455 754 the rail infrastructure owner in respect of Main South Rail Line hereby gives notice in accordance with section 99B(3)(a) of the *Transport Administration Act 1988* (the Act) of the proposed closure of the level-crossing described below:

The Minister for Transport and Roads has approved the closure under section 99B(1) of the Act.

The date of closure will be the 31st of May 2023

Section 99B(4) of the Act provides that on closure of a level-crossing under that section all rights, easements and privileges in relation to that level-crossing are extinguished.
