Sale of Land for Overdue Rates

Wentworth Shire Council resolved on 15 February 2023, in accordance with Section 713 of the Local

Government Act 1993, to sell land for overdue rates. This resolution date was advertised in the NSW Government Gazette on 17 March 2023 as 27 October 2022 but should have read 15 February 2023.

Benwerrin Reserve for a reserve parallel to Benwerrin Crescent in the suburb of Grasmere, Camden Local Government Area (LGA).

Sickles Creek Reserve for a reserve commencing at Werombi Road and traveling south for about 1.1 km along Sickles Creek in the suburb of Grasmere, Camden Local Government Area (LGA).

Smalls Reserve for a reserve accessed from Smalls Road and Cawdor Farms Road in the Suburb of Grasmere, Camden Local Government Area (LGA).

Notification of Road Closure


