Detail

A special event will take place on Sydney Harbour at the above location, being filing of a motion picture.

Exclusion Zone

An Exclusion Zone will be established in the location above for the duration of the filming activities, as per the attached map, and will be patrolled and indicated by Police, Maritime and other official control vessels.

The Exclusion Zone will be activated from the Port Lateral mark off Sydney Opera House to Mrs Macquarie's Point in an arc between the above times on the above dates, and will be enforced by Maritime control vessels. The activation and deactivation of the Exclusion Zone will be announced on VHF 13. In the event of inclement weather, the Exclusion Zone may not be activated.

Unauthorised vessels and persons are strictly prohibited from entering the Exclusion Zone.

Penalties may apply (section 12(5) - Marine Safety Act 1998).

REGULATION OF VESSELS – EXCLUSION ZONE AND SPECIAL RESTRICTIONS

Location

Murray River, Mildura – between the George Chaffey Bridge and the Mildura Weir

Duration

6.30am to 7.30pm on the following dates:

- Tuesday 28 March 2023
- Wednesday 29 March 2023
- Thursday 30 March 2023
- Friday 31 March 2023
- Saturday 1 April 2023

Detail

A wakeboarding competition will be conducted on the navigable waters of Murray River, Mildura specified above. There will be support vessels present to manage the event, persons in the water from time to time, and persons being towed at speed using tow-lines, presenting a significant potential hazard to other waterway users.

An **EXCLUSION ZONE** is specified during the event which will be monitored by control vessels and comprise the entire width of the location above. This will effectively close the River to all other vessel use between the above times for this event.

Unauthorised vessels and persons are strictly prohibited from entering the Exclusion Zone.

Transit Arrangements

At various times during the event, control vessels may authorise local vessel traffic to transit the zone.

Special Restrictions

Pursuant to section 12(3) of the Act, vessels transiting the zone must do so at a speed not exceeding 4 knots and must produce minimal wash.

Penalties may apply (section 12(5) - Marine Safety Act 1998)

A wakeboarding event will be conducted on the navigable waters of the Clarence River specified above.

An **EXCLUSION ZONE** for is specified during the event, which will be marked by a series of buoys and be patrolled by Maritime and Police vessels.

Unauthorised vessels and persons are strictly prohibited from entering the Exclusion Zone.

Transit lane

Provision may be made (where necessary) for a control vessel to authorise local vessel traffic to pass safely through the Exclusion Zone via a 'transit lane'.

Special Restrictions

Pursuant to section 12(3) of the Act, vessels using the transit lane must do so at a speed not exceeding 4 knots and must produce minimal wash.

Penalties may apply (section 12(5) - Marine Safety Act 1998).

Detail

Marine construction works involving the installation of underwater pipelines and jet pumps will occur on the navigable waters of the Coffs Harbour specified above. The navigable channel will at times be impacted by the use of plant and machinery, overhead hazards, floating construction materials, and commercial divers.

An **EXCLUSION ZONE** is specified during the event which will be monitored by Authorised Officers and control vessels.

REGULATION OF VESSELS - EXCLUSION ZONE AND SPECIAL RESTRICTIONS

Location

Lake Mulwala – near the locality of the Mulwala Water Ski Club and within an area bounded by:

- The Mulwala foreshore between the land-based localities of the Lake Edge Resort and south to the Melbourne Street Bridge, then
- East into Lake Mulwala for a distance of approximately 750 metres, then
- North to a location directly east of the Lake Edge Resort.

Duration

7:00am to 6:00pm on the following dates:

Saturday 1 and Sunday 2 April 2023

Detail

Competitive powerboat racing will be conducted on the navigable waters of Lake Mulwala at the location and times specified above, presenting a significant potential hazard to other waterway users.

An **EXCLUSION ZONE** is specified during the event, which will be marked by buoys and monitored by control and patrol vessels.

Unauthorised vessels and persons are strictly prohibited from entering the Exclusion Zone.

Transit Lane

A 'transit lane' will be established along the foreshore from the Lake Mulwala Holiday Park, south of the Mulwala Water Ski Club, to the Melbourne Street bridge, Mulwala, within which a control vessel may, at times during the event, authorise local vessel traffic to pass through.

Special Restrictions

Pursuant to Section 12(3) of the Marine Safety Act 1998, special restrictions are applicable to vessels using the transit lane:

- Maximum speed limit of 4 knots, and
- Minimal wash must be produced.

Penalties may apply (section 12(5) - Marine Safety Act 1998)
