

Section 516(1A)

ORDER

Maximum tariff for purposes of the definition of boarding house and lodging house

Under delegation from the Minister administering the *Local Government Act 1993* (the Act), I determine that for the period 1 July 2023 to 30 June 2024 (inclusive) the maximum tariff, exclusive of GST, for a boarding house or lodging house for the purposes of section 516(1A) of that Act is:

- (a) Where full board and lodging is provided-\$432 per week for single accommodation; or\$713 per week for family or shared accommodation.
- (b) Where less than full board and lodging is provided-\$291 per week for single accommodation; or\$479 per week for family or shared accommodation.
