Fisheries Management (Estuary General Prawning Codend) Order 2023

Fisheries Management Act 1994

Part 1 Preliminary

1. Name of Order

This Order is the Fisheries Management (Estuary General Prawning Codend) Order 2023.

2. Commencement and Duration

- (1) This order commences on the date of publication.
- (2) This order remains in force for a period of 5 years.

3. Definitions

In this Order:

codend of a net means the piece of netting that forms the posterior most part of the net where the catch accumulates.

endorsement holder means a person who holds a commercial fishing licence that has an estuary general prawning endorsement as described in clause 6 of the EG Plan.

EG fishery means the estuary general share management fishery, as described in Schedule 1 to the Act.

the Act means the Fisheries Management Act 1994.

EG Plan means the appendix to the *Fisheries Management (Estuary General Share Management Plan) Regulation 2006.*

Note: Under section 11 of the *Interpretation Act 1987*, unless otherwise specified words in this Order have the same meaning as in the Act.

Part 2 Special approval for authorised purposes

- 4. Square shaped mesh codend prawn net (hauling), prawn net (hauling) Manning River, prawn net (hauling) Wallis Lake, seine net (prawns) and try net (prawns)
 - (1) This clause applies to these nets:
 - (a) prawn net (hauling),
 - (b) prawn net (hauling) Manning River,
 - (c) prawn net (hauling) Wallis Lake,
 - (d) seine net (prawns), and
 - (e) try net (prawns).
 - (2) Despite clauses 21, 22, 23 and 26 of the EG Plan, in the waters of the EG fishery, it is lawful for an endorsement holder to use a square shaped mesh codend that is constructed of knotted polyamide or polyethylene material.
- 5. Square shaped mesh codend prawn net (set pocket)

Despite clause 24 of the EG Plan, in the waters of the EG fishery, it is lawful for an endorsement holder to use a prawn net (set pocket) with a square shaped mesh codend that:

- (a) is constructed of knotted material,
- (b) is constructed of any material type; and
- (c) has a circumference not exceeding 3 metres.
- 6. Diamond shaped mesh codend prawn net (hauling), prawn net (hauling) –
 Manning River, prawn net (hauling) Wallis Lake, seine net (prawns) and try net
 (prawns)
 - (1) This clause applies to these nets:
 - (a) prawn net (hauling),
 - (b) prawn net (hauling) Manning River,
 - (c) prawn net (hauling) Wallis Lake,
 - (d) seine net (prawns), and
 - (e) try net (prawns).

- (2) Despite clauses 21, 22, 23 and 26 of the EG Plan, in the waters of the EG fishery, it is lawful for an endorsement holder to use a diamond shaped mesh codend that:
 - (a) consists of diamond-shaped mesh not less than 30 mm nor more than 36 mm,
 - (b) is constructed of knotted material,
 - (c) is constructed of any material type,
 - (d) is constructed of material comprising twine of any diameter,
 - (e) has a circumference of any size; and
 - (f) is of any length.

7. Diamond shaped mesh codend - prawn net (set pocket) - all waters except Wallis Lake

Despite clause 24(5) of the EG Plan, in all waters of the EG fishery except Wallis Lake, it is lawful for an endorsement holder to use a prawn net (set pocket) —with a codend that:

- (a) consists of diamond-shaped mesh not less than 30 mm nor more than 40 mm,
- (b) is constructed of material comprising twine of any diameter; and
- (c) has a circumference of any size.

Part 1 Preliminary

1. Name of Notification

This notification is the Fisheries Management (Commercial Harvest of Abalone Fishing Closure) Notification 2023.

2. Commencement and duration

This notification commences on the date it is published in the NSW Government Gazette and will remain in force for a period of five years, unless sooner varied or revoked.

3. Revocation of Fishing Closure Relating to the Commercial Harvest of Abalone

Under section 11 of the Act, the *Fishing Closure Relating to the Commercial Harvest of Abalone* and published in *NSW Government Gazette* No. 69 of 13 July 2018, at pages 4241-4242 is revoked, as is any fishing closure revived because of this revocation.

4. Definitions

In this notification:

abalone fishery means the abalone fishery as described in clause 4 of Schedule 1 to the Act.

endorsement holder has the same meaning as in clause 2 of the Appendix to the Abalone Plan.

fishing closure has the same meaning as in section 8 of the Act.

fishing period has the same meaning as in clause 2 of the Appendix to the Abalone Plan.

legal minimum length means the shell diameter measured along the shell's longest axis.

McEwan Point means the point on Aragannu Beach (36°35.320′ S, 150°2.620′ E).

pre-fishing report means a report made in accordance with condition 1 of the endorsement conditions that apply to an endorsement holder. It is a condition of an endorsement in the abalone fishery that an endorsement holder must use the Real Time Reporting System and report specific information to the Department each occasion on which the endorsement holder proposes to take abalone under the endorsement.

the Abalone Plan means the Fisheries Management (Abalone Share Management Plan) Regulation 2000.

Part 2 Fishing closure

5. Fishing closure

Under section 8 of the Act:

- (a) prohibit the taking of abalone (*Haliotis rubra*) by all endorsement holders in the abalone fishery in waters described in Column 1 of Schedule 1 to this notification, except on the conditions specified opposite in Column 2 of Schedule 1.
- (b) during a fishing period, if the total quantity of abalone specified in Column 1 of Schedule 2 is taken by endorsement holders from the waters described opposite in Column 2 of Schedule 2, all the endorsement holders are prohibited from taking abalone from the waters described in Column 2 for the remainder of the fishing period.

The whole of the waters north of the McEwan point on Araganu Beach $(36^{\circ}35.320' \text{ S}, 150^{\circ}2.620' \text{ E})$, to the whole of the waters south of the point on Redhead Beach (33°1.320′ S, 151°42.390′ E).

Any abalone taken must have a legal minimum length of 117mm or greater.

In addition to making a pre-fishing report an endorsement holder must notify the local District Fisheries office in writing the expected date, time/s, and location/s of any fishing activity prior to proceeding to sea.

Where the endorsement holder takes abalone across waters subject to a different legal minimum length, the highest legal minimum length applies for all catch taken on that day.

The whole of the waters north of the entrance to Wonboyn Lake (37°15.074'S, 149°58.021'E) to the whole of the waters south of the McEwan point on Aragannu Beach (36°35.320′ S, 150°2.620′ E).

The whole of the waters north of the point on Redhead Beach (33°1.320' S, 151°42.390′ E) to the Queensland border.

Any abalone taken must have a legal minimum length of 120 mm or greater.

Part 1 Preliminary

1. Name of Order

This order is the Fisheries Management (Yarrahapinni Wetlands Aboriginal Cultural Fishing Special Approval) Order 2023.

2. Commencement and duration

- (1) This order commences on the date it is published in the *NSW Government Gazette*.
- (2) This order will remain in force for 3 years commencing on the date of publication.

3. Definitions

(1) In this order:

LCF means a cultural fisher who is listed in Schedule 2 to this order.

YWCF - see clause 4.

YWACF Area refers to the Yarrahapinni Wetlands Aboriginal Cultural Fishing Area - see clause 5.

the Regulation means the Fisheries Management (General) Regulation 2019.

immediate vicinity means an area in which an individual is physically present with another individual where those individuals can see, hear, and direct the activities of each other.

(2) Words and expressions in this order have the same meaning as they have in the Regulations unless otherwise specified in this order.

4. Persons to whom this Order applies

- (1) This order applies to all YWCFs.
- (2) A LCF is a YWCF.
- (3) An Aboriginal person is a YWCF if that person is in a category and meets the criteria for that category in the Table.

Table

Category	Criteria
Child or dependent	1. The person is less than 18 years of age and is:
	 a. a child of a LCF by blood, marriage, de-facto marriage, adoption, step, fostering or kinship care who is usually resident in the same household as the LCF, or
	 a child of a LCF by blood, marriage, de-facto marriage, adoption, step, fostering or kinship care who is not usually resident in the same household as the LCF because of parental separation.
	A person is less than 18 years of age and is a lineal descendant of a LCF such as a grandchild, great-grandchild or great-grandchild of a LCF.
Young adult	The person is over the age of 18 and was a child or dependent as defined by the criteria in this table on the date on which this order commenced.
Friend or relative who is not a child, dependent or young adult as per the category and criteria in this table.	The person is known to a LCF and is participating in fishing activities within the immediate vicinity of an LCF, child, dependant or young adult described in this table.

5. Waters to which this order applies

- (1) This order applies to the YWACF Area.
- (2) The **YWACF Area** is the all waters within the Yarrahapinni Wetlands National Park and its creeks and tributaries extending upstream of a line drawn from the southwest entrance to Yarrahapinni Wetlands at 30° 54.158'S, 152° 59.200'E,

then in a northerly direction for approximately 350 metres to the point 30° 53.963'S, 152° 59.245'E, then in an north-easterly direction for approximately 300 metres to the point 30° 53.898'S, 152° 59.414'E, and then in a south-easterly direction of approximately 210 metres to the eastern side of the rock revetment adjacent to Golden Hole.

6. Aboriginal cultural fishing

- (1) This order authorises a YWCF:
 - (a) to take fish in the YWACF Area for the purposes of Aboriginal cultural fishing,
 - (b) possess the fish taken under (a) for the purpose of Aboriginal cultural fishing, and
 - (c) to carry out the fishing activities described in the order in the YWACF Area for the purposes of Aboriginal cultural fishing.
- (2) This order does not authorise a YWCF to take fish from the YWACF Area for sale.

Part 2 Special Approvals – Fishing gear and fishing activities

7. Fishing gear

- (1) It is lawful for a YWCF to take fish using recreational gear and recreational methods outlined in the Regulation within the YWACF Area.
- (2) Despite clause 50 of the Regulation, it is lawful for a YWCF to hook a crab using a crab wire, but the crab wire must not penetrate the crab's shell or otherwise damage or harm the crab.
- (3) Despite clause 52 of the Regulation, it is lawful for a YWCF to use a spear gun aided by lights in the YWACF Area for the purpose of taking fish.
- (4) In this clause –

spear gun means a spear or similar device and includes a traditional-style hand or rubber propelled straight shafted spear constructed of natural or synthetic materials with a single spear point or prong, or multi-pronged head.

crab wire means an implement made from a small-diameter, round, steel bar, with one end bent into a right-angle hook, which is hooked behind the crab to drag within reach of hand capture.

8. Fishing activities

- (1) Despite clause 87 of the Regulation, a YWCF may shuck rock lobster and turban shell and have shucked lobster and turban shell in their possession, in or on or within 100 metres of the high water mark of waters in the YWACF Area.
 - (2) Despite clause 88 of the Regulation, a YWCF may shuck abalone, or have shucked abalone in their possession, in or on or within 100 metres of the high water mark of waters in the YWACF Area.

Part 3 Special Approvals – Bag limits

9. Bag limits

Despite clauses 8, 9 and 10 of the Regulation, the daily limit and possession limit for a species of fish are specified in Schedule 1 to this order.

Note. Other than where expressly stated, this order does not authorise fishing activities in contravention of the Act or any regulations under the Act.

Following the granting of the lease areas, an inspection by a Fisheries Office will be completed and a Notice to Comply may be issued for the removal of any improvements. Any unauthorised structures present on the area will require removal by the successful tenderer(s) or authorisation by the relevant authority.

For the lease areas located in the Port Stephens-Great Lakes Marine Park, Batemans Marine Park or Solitary Islands Marine Park, the successful tenderers will be required to apply for a Marine Parks work permit before placing any cultivation material on the lease areas.

For lease areas known as AL19/005, AL21/019 and AL23/008, the successful tenderer(s) will be required to obtain an approved survey of the lease area(s), to be completed by a registered surveyor at the expense of the successful tenderer(s).

Any lease granted as a result of the tender will be subject to standard covenants and conditions of an aquaculture lease and aquaculture permit, as prescribed under the *Fisheries Management Act 1994*, including payment of annual fees and charges.
