Rowing Regattas will be conducted on the navigable waters of the Manning River, Taree specified above.

An **EXCLUSION ZONE** is specified for the event, which will consist of a 2 kilometre course that will be marked by buoys and monitored by control vessels.

Provision has been made for vessels to transit the Zone during breaks in the racing. Control vessels will, at times during the event, authorise local vessel traffic to transit the Zone.

Unauthorised vessels and persons are strictly prohibited from entering the Exclusion Zone.

REGULATION OF VESSELS – EXCLUSION ZONE

Location

Manning River – between the Martin Bridge at Taree, along the Manning River South Passage, to Harrington.

Duration

- 8.00am to 5.00pm Saturday 6 May 2023
- 8.00am to 12.00pm Sunday 7 May 2023

Detail

Competitive water ski races will be conducted on the navigable waters of the Manning River as specified above. The event will involve the use of high-speed power vessels, persons being towed at speed using towlines, and persons in the water from time to time, presenting a significant potential hazard to other waterway users.

An **EXCLUSION ZONE** is specified during the event, which will be monitored by control vessels and indicated by the presence of support vessels on the perimeters.

Unauthorised vessels and persons are strictly prohibited from entering the Exclusion Zone.

Transiting vessels

Provision has been made for vessels to transit the Zone during breaks in racing. Control vessels (via race control vessels and control points on shore) will, at times during the events, authorise local vessel traffic to transit the Zone.

REGULATION OF VESSELS - EXCLUSION ZONE & SPECIAL RESTRICTIONS

Location

Hastings River – near the locality of Port Macquarie as follows:

- Ironman Practice Swims between the Marine Rescue boat ramp and the downstream side of the Park Street Road bridge adjacent to the Broadwater Main Canal
- Ironman Races between the Marine Rescue boat ramp and the Broadwater Main Canal.

Duration

- 6.00am to 9.00am Friday 5 May to Saturday 6 May 2023 (Ironman Practice Swims)
- 6.00am to 11.30am Sunday 7 May 2023 (Ironman Races)

Detail

Ironman Practice Swims and the Ironman Races will be conducted on the Hastings River during the above times and at the locations specified above.

An **EXCLUSION ZONE** is specified during the events, which will be monitored by control vessels. The Zone will be indicated by the presence of control vessels on the perimeter of the zones.

Unauthorised vessels are strictly prohibited from entering the Exclusion Zone.

Special Restrictions

Pursuant to section 12(3) of the *Marine Safety Act 1998,* vessels transiting the zone must do so at a speed not exceeding 4 knots and must produce minimal wash.

Detail

Water Ski Races will be conducted on the navigable waters of Lake Albert, Wagga Wagga as specified above. This will involve the use of powered vessels, persons being towed at speed using tow-lines and persons in the water from time to time, presenting a significant potential hazard to other waterway users.

An **EXCLUSION ZONE** is specified during the event and will comprise the entirety of Lake Albert, be monitored and maintained by event officials and support and control vessels.

Unauthorised vessels and persons are strictly prohibited from entering the Exclusion Zone.
