1 Name of Instrument

3 Precondition for making this Instrument

- (1) On 21 November 2022, the Minister directed under section 40C(3) of the Act, that the Secretary was to make TAC determinations for the OH species, the OTL species and tiger flathead (*Platycephalus richardsoni*) in the ocean trawl fishery, for the fishing period 1 May 2023 to 30 April 2024.

- (1) An endorsement holder is prohibited from taking fish within 200 metres of the mean low water mark of the whole of the ocean waters adjacent to the shoreline from Little Nobby at Crescent Head (latitude 31° 11' 9.6288" S, longitude 152° 59' 2.835" E) travelling generally west along the shoreline to the mouth of Killick Creek, and then generally north along Killick Beach for a further distance along that beach of 1km (to the line of latitude at 31° 10' 40.8612" S, 152° 58' 30" E).
- (2) Despite subclause (1), an endorsement holder is not prohibited from taking fish in the waters described in subclause (1) using any of the following nets, where those nets are cast from and hauled back to a boat:
 - (a) garfish net (hauling),
 - (b) pilchard, anchovy and bait net (hauling).
