Mineral Allocation Area Order for Hydrogen and nonmetals 2022

Mining Act 1992

1. Name of Order

This Order is the *Mineral Allocation Area Order for Hydrogen and nonmetals 2022*.

2. Commencement

This Order commences on 1 March 2023.

3. Mineral Allocation Area

The whole of New South Wales is constituted as a Mineral Allocation Area for Group 12 minerals (Hydrogen and nonmetals) and the individual minerals argon, helium, other than excluded helium, hydrogen, krypton, neon, radon and xenon.
