Kirribilli Point to Garden Island to Bradleys Head, Sydney Harbour.

#### **Duration**

- 8:00am 5:00pm Tuesday 16 May 2023.
- 8:00am 5:00pm Thursday 18 May 2023 (weather contingency)

## **Detail**

Filming will take place on and over the waters of Sydney Harbour at the above times on Tuesday 16 May 2023. In the event of inclement weather filming may be delayed until Thursday 18 May 2023. The activity will require the use of helicopters at low altitude for both filming and as part of the show content and as such will require the activation of Exclusion Zones.

An **EXCLUSION ZONE** is specified during the event times listed at the above location, which will be marked by the presence of Maritime and Water Police control vessels. The Exclusion Zones will be activated and deactivated as required. Activation and deactivation will be broadcast over VHF13 by Maritime Control vessels.

Unauthorised vessels and persons are strictly prohibited from entering the exclusion zone.

Penalties may apply (section 12(5) - Marine Safety Act 1998).
