## Anti-Discrimination Act 1977

#### **EXEMPTION ORDER**

# GAS AND ELECTRICTY (CONSUMER SAFETY) ACT 2017 SECTION 28(1) NOTICE

To all persons:

- I, David Byrne, Director of Investigations, Intervention and Review, NSW Fair Trading, having reasonable grounds to believe that:
  - a) A gas appliance described and commonly known as an *LPG Cabinet Heater* are a type of gas appliance which is unsafe to use; and
  - b) The death of, or injury to, any person, or damage to any property that may lead to the death, or injury to any person, may arise out of the use of an LPG Cabinet Heater unless this Notice is made.

Prohibit, pursuant to section 28(1) of the Gas and Electricity (Consumer Safety) Act 2017, the sale or supply of LPG Cabinet Heaters.

#### Interpretation:

In this Notice:

"LPG Cabinet Heater" means a flueless portable heater incorporating a *liquid petroleum gas container* mounted integrally within the heater casing directly behind the burner.

"liquified petroleum gas" means a liquid or gaseous substance containing a mixture of hydrocarbons, basically consisting of butane or butene or propane or propene, or any mixture of them.

"container" includes a gas cylinder and a gas tank.
