Detail

A competitive powerboat racing event will be conducted on the Hawkesbury River – as specified above – involving the use of high-speed powerboats which will be active in the area during the above times.

Competing vessels will race at high speed which will present a significant hazard to other waterway users.

An **EXCLUSION ZONE** is specified during the event which will be marked by the presence of buoys at the location detailed above. Unauthorised vessels and persons are strictly prohibited from entering the Exclusion Zone, which will be monitored by control vessels.

Penalties may apply (section 12(5) - *Marine Safety Act 1998*)

**POINT TO POINT TRANSPORT (PORT MACQUARIE TAXI CABS)
EXEMPTION ORDER 2023**

under the

Point to Point Transport (Taxis and Hire Vehicles) Regulation 2017

I, Anthony Wing, Point to Point Transport Commissioner, do pursuant to clause 92 of the *Point to Point Transport (Taxis and Hire Vehicles) Regulation 2017* make the following Order.

1 Name of Order

This Order is the *Point to Point Transport (Port Macquarie Taxi Cabs) Exemption Order 2023*.

2 Commencement

This Order commences on 24 May 2023.

3 Effect

This Order remains in force from the date of its commencement, up to and including the date that is 14 days after the ending of the transitional period, unless revoked earlier.

4 Interpretation

Words and expressions in this Order have the same meaning as in the *Point to Point Transport (Taxis and Hire Vehicles) Act 2016* or the *Point to Point Transport (Taxis and Hire Vehicles) Regulation 2017* unless otherwise stated.

Act means the *Point to Point Transport (Taxis and Hire Vehicles) Act 2016*.

Regulation means the *Point to Point Transport (Taxis and Hire Vehicles) Regulation 2017*.

Transitional period means the period, as defined in clause 19 of Part 3 of Schedule 2 of the *Point to Point Transport (Taxis and Hire Vehicles) Act 2016*. This period commenced on 1 February 2023.

Port Macquarie Taxi Cabs means Minvell Corporation Pty Limited (trading as Port Macquarie Taxi Cabs).

5 Exemptions

Subject to the conditions in clause 6, Port Macquarie Taxi Cabs and the holder of the number-plates allocated to vehicle TC1274, are exempt from the following requirements:

- the requirement under Part 4 of the Act that the motor vehicle with vehicle registration TC1274 used to provide a taxi service is a motor vehicle for which Port Macquarie Taxi Cabs, or an employee, contractor or affiliated provider of Port Macquarie Taxi Cabs must hold a licence under section 47 of the Act; and
- the requirement under sub section 130(2) of the Act for the holder of the number-plates allocated to vehicle TC1274 to return the number-plates within 7 days of the suspension, cancellation or licence otherwise ceasing to have effect.

6 Conditions

- i. Port Macquarie Taxi Cabs continues to be authorised under Part 3 of the Act to provide a taxi and booking service.
- ii. Port Macquarie Taxi Cabs must ensure that only vehicle TC1274 is used to provide a taxi service whilst not holding a licence under Part 4 of the Act.
- iii. Port Macquarie Taxi Cabs must ensure that the drivers of motor vehicle TC1274 used to provide a taxi service, comply with the following clauses of the Regulation:
 - Cl 24 (disqualifying offences)
 - Cl 25 (ineligible drivers)
 - Cl 59 (driver not to smoke in vehicle)
 - Cl 60 (offensive behaviour by drivers)
 - Cl 63 (additional passengers)
 - Cl 64 (assistance animals)
 - Cl 66 (no touting or soliciting for passengers)
 - Cl 70 (driver to supply information on hirings)
 - Cl 71 (driver to hand over driver licence for inspection)
 - Cl 74 (interference with safety devices)
 - Cl 75 (standing otherwise than in a taxi zone)
 - Cl 76 (use of taxi zones)
 - Cl 81 (operation of fare calculation device)
- iv. The holder of the number-plates allocated to vehicle TC1274 must make an application for a taxi licence within 14 days of the transitional period ending.

Note: An exemption that is conditional ceases to have effect if the condition is not observed.

Explanatory note

This Exemption Order allows motor vehicle TC1274, which was used by Port Macquarie Taxi Cabs to provide taxi services under a licence existing prior to the commencement of the transitional period, to continue to provide taxi services, until the end of the transitional period.

It exempts Minvell Corporation Pty Limited (trading as Port Macquarie Taxi Cabs) and the holder of the number-plates allocated to vehicle TC1274 from:

- the requirement that motor vehicle TC1274, used by Port Macquarie Taxi Cabs to provide a taxi service, is a motor vehicle for which Port Macquarie Taxi Cabs, or an employee, contractor or affiliated provider of Port Macquarie Taxi Cabs, is the holder of a taxi licence issued under Part 4 of the Act; and
- the requirement under sub section 130(2) of the Act for the holder of the number-plates allocated to vehicle TC1274 to return the number-plates within 7 days of the suspension, cancellation or licence otherwise ceasing to have effect.
