- 7.00am to 11.30am – Sunday 2 July 2023

**Detail**

Water ski races will be conducted on the open waters between Main Beach and Bennetts Head, as specified above.

An **EXCLUSION ZONE** is specified during the event, which will be marked with buoys and monitored by control vessels.

Unauthorised vessels and persons are strictly prohibited from entering the Exclusion Zone during the times above.

REGULATION OF VESSELS – EXCLUSION ZONE

**Location**

Clarence River, between Maclean and Lawrence - from the downstream extremity of Munro Island to the confluence of Sportsman's Creek.

**Duration**

7:00am to 12:00pm – Wednesday 21 June 2023

**Detail**

A Sail Past will be conducted on the navigable waters of Clarence River specified above.

An **EXCLUSION ZONE** will be in force and will comprise a 200 metre radius surrounding the participating vessels.

Unauthorised vessels and persons are strictly prohibited from entering the Exclusion Zone, which will be monitored by control vessels.
