MENTAL HEALTH ACT 2007 Section 109 Declaration of mental health facility

- I, PATRICIA O'RIORDAN, Acting Executive Director, Mental Health Branch, acting under delegation from the Secretary of the NSW Ministry of Health, and pursuant to section 109 of the Mental Health Act 2007, and section 43 of the Interpretation Act 1987, DO HEREBY:
- (a) REVOKE Order n2022-0305 published in NSW Government Gazette No. 69 of 25 February 2022, declaring certain premises of Bloomfield Hospital to be a mental health facility in accordance with section 109 of the Mental Health Act 2007; and
- (b) DECLARE the following premises of **Bloomfield Hospital** to be a declared mental health facility for the purposes of section 109 of the *Mental Health Act 2007*:

Bloomfield Mental Health Service Centre, situated at Bloomfield Hospital Campus, Orange Health, Forest Road, Orange NSW 2800, comprising the following units:

- Adult Acute Unit, Lachlan Building, located on The Avenue
- Amaroo Unit, located on Canobolas Drive
- Castlereagh Unit, Windamere Building, located on Canobolas Drive
- Infant, Child, Youth and Family Unit, Building 13, located on The Crescent
- Macquarie Unit, Windamere Building, located on Canobolas Drive
- Manara Clinic, located on Canobolas Drive
- Mental Health Intensive Care Unit, Lachlan Building, located on The Avenue
- Older Persons Acute Unit, Lachlan Building, located on The Avenue
- Turon House, located on Canobolas Drive
- Wattle Grove, located on Canobolas Drive; and

(c) DECLARE this facility to be designated in the class of facilities known as "mental health assessment and inpatient treatment" class.

MENTAL HEALTH ACT 2007 Section 109 Declaration of Mental Health Facility

- I, PATRICIA O'RIORDAN, Acting Executive Director, Mental Health Branch, acting under delegation of the Secretary, NSW Ministry of Health, and pursuant to section 109 of the *Mental Health Act 2007*, and section 43 of the *Interpretation Act 1987*; DO HEREBY:
- (a) REVOKE Order n2023-0889 published in NSW Government Gazette No. 240 of 2 June 2023, declaring certain premises of Bloomfield Campus, Orange to be a mental health facility in accordance with section 109 of the *Mental Health Act 2007*; and
- (b) DECLARE the following premises of **Bloomfield Campus, Orange** to be a declared mental health facility for the purposes of the Mental Health Act 2007:
 - Emergency Department of Orange Health Service, located in the Orange Health Service Building (General Hospital), The Avenue, 1530 Forest Road, ORANGE NSW 2800; and
- (c) DECLARE this facility to be designated as a "mental health emergency assessment class" facility; and
- (d) RESTRICT this facility to the provision of acute assessment functions, where a patient can be held in anticipation of discharge should their clinical condition resolve rapidly, or transferred to a declared mental health facility of the "mental health assessment and inpatient treatment" class if required, in accordance with all provisions of the *Mental Health Act 2007*, with the exception of:
- i. Chapter 2;
- ii. Division 3 of Part 2 of Chapter 3;
- iii. Division 1 of Part 3 of Chapter 3;
- iv. Sections 57 and 58 of Division 2 of Part 3 of Chapter 3.
