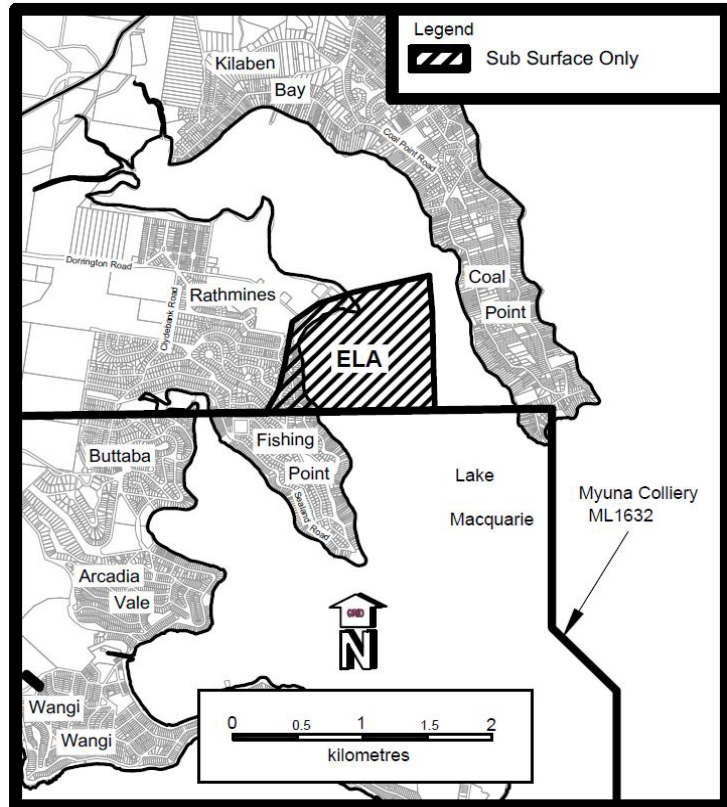
## Market Interest Test – Coal Operational Allocation

Market Interest Test submission closing: Saturday 19 August 2023 at 11:59pm (AEST)

Centennial Myuna Pty Limited (ACN 101 508 981) has applied to the Department of Regional NSW – Mining Exploration and Geoscience (MEG) for a Group 9 (coal) exploration licence for operational allocation purposes in accordance with section 13C of the *Mining Act 1992*.

Exploration Licence Application No. 6632 (Act 1992) is located about 5.58 kilometres east-southeast of Awaba, over an area of 108.375 hectares. ELA 6632 embraces the strata between the depths of 20 metres below the surface of the land and 30 metres below the bed of Lake Macquarie to 5 metres below the floor of the Fassifern Seam.

MEG is required to assess any market interest for the application by Centennial Myuna Pty Limited – ELA 6632 and is seeking submissions from parties interested in exploring and potentially developing coal resources within the application area.



The application area where submissions are being sought can be seen in the diagram.

Any valid submissions may trigger a competitive process for the release of the area. Submissions should only be made where a party has a genuine interest in making an application for an exploration licence and where interested parties are willing to participate in a competitive process if it was to be triggered.

This notification is pursuant to section 13C(3)(b) of the *Mining Act 1992* and the *Guidelines for coal exploration licence applications for operational allocation purposes* and does not constitute an invitation for a coal exploration licence or mining lease nor a release of the area under the Strategic Release Framework.
