Each notice in the Government Gazette has a unique reference number that appears in parentheses at the end of the notice and can be used as a reference for that notice (for example, (n2019-14)).





ACTS OF PARLIAMENT ASSENTED TO

Legislative Council Office Sydney 3 July 2023

IT is hereby notified, for general information, that Her Excellency the Governor has, in the name and on behalf of His Majesty, this day assented to the undermentioned Acts passed by the Legislative Council and Legislative Assembly of New South Wales in Parliament assembled, viz.:

Act No. 6, 2023 – An Act to amend the Parliamentary Remuneration Act 1989 to provide for a temporary freeze on increases to the basic salary of members of both Houses of Parliament. **[Parliamentary Remuneration Amendment Bill 2023]**

Act No. 7, 2023 – An Act to amend certain other Acts and instruments in various respects and for the purpose of effecting statute law revision; and to make certain savings. **[Statute Law (Miscellaneous Provisions) Bill 2023]**

Act No. 8, 2023 – An Act to amend the Statutory and Other Offices Remuneration Act 1975 to provide for a temporary freeze on increases in remuneration for office holders under Part 3 of that Act and executive office holders and senior executives under Parts 3A and 3B of that Act; and for related purposes. **[Statutory and Other Offices Remuneration Amendment Bill 2023]**
