Detail

Rowing regatta races will be conducted on the navigable waters of Clarence River, Grafton as specified above.

An **EXCLUSION ZONE** is specified during the events, which will be marked by buoys and monitored by control vessels.

Unauthorised vessels and persons are strictly prohibited from entering the Exclusion Zone.

Penalties may apply (Section 12(5) - Marine Safety Act 1998)
