## 1 Name of Instrument

This Instrument is the *Fisheries Management (Fishing Determination – Eastern Rock Lobster) Notification 2023*.

## 2 Definitions

In this Instrument:

*eastern rock lobster* means fish of the species *Sagmariasus verreauxi*.

*Lobster Plan* means the Appendix to the Fisheries Management (Lobster Share Management Plan) Regulation 2000.

*TAC determination* has the same meaning as in section 40A of the Act.

*TAF Committee* means the Total Allowable Fishing Committee.

*the Act* means the *Fisheries Management Act 1994*.

## 3 Notice of TAC determination for Eastern Rock Lobster

- (1) Under section 40D of the Act and clause 52A of the Lobster Plan, the Total Allowable Fishing Committee has determined that for the fishing period 1 August 2023 to 31 July 2024 the TAC determination for eastern rock lobster is 200 tonnes.
- (2) This TAC determination has effect for the period 1 August 2023 to 31 July 2024.
