Anti-Discrimination Act 1977

EXEMPTION ORDER

Under the provisions of section 126 of the *Anti-Discrimination Act* 1977 (NSW), an exemption is given from sections 8 and 51 of the *Anti-Discrimination Act* 1977 (NSW) to Narrabri Shire Council to designate, advertise and recruit for up to 10 positions for Aboriginal and Torres Strait Islander persons only including the Aboriginal Liaison Officer and Library Officer positions

This exemption will remain in force for 10 years.

Anti-Discrimination Act 1977

EXEMPTION ORDER

Under the provisions of section 126 of the *Anti-Discrimination Act 1977* (NSW), an exemption is given from sections 8 and 51 of the *Anti-Discrimination Act 1977* (NSW) to Ausgrid to advertise, designate and recruit roles for Aboriginal and Torres Strait Islander persons only in pursuit of a 3% Aboriginal and Torres Strait Islander workforce participation rate.

This exemption will remain in force for 3 years.

Exemption from provisions of the *Combat Sports Act 2013*Persons not ordinarily resident in Australia participating as trainers or seconds at UFC 293

The Combat Sports Authority of NSW (the "**Authority**") exempts the specified class of persons described below from the requirement to be registered under section 20(1) of the *Combat Sports Act 2013* [NSW] (the "**Act**") in the registration classes: trainer-professional-mixed martial arts and second-professional-mixed martial arts, subject to the conditions listed below, pursuant to section 102(1) of the Act.

Specified class of persons

Persons not ordinarily resident in Australia participating as trainers or seconds at the professional mixed martial arts contest to be held at Qudos Bank Arena, Sydney Olympic Park, NSW on 10 September 2023 ("**UFC 293**"), that do not satisfy the registration exemption provisions contained in clause 62(2) of the *Combat Sports Regulation 2014* [NSW].

Conditions on this exemption

This exemption is granted subject to the following conditions imposed pursuant to section 102(3) of the Act.

- (1) Persons subject to this exemption must provide to the Authority by 6pm on Friday 8 September 2023 evidence that satisfies the Authority of their identity.
- (2) Persons subject to this exemption must provide to the Authority by 6pm on Friday 8 September 2023 the name of each combatant that they will be assisting at UFC 293.
