**CHARITABLE TRUSTS ACT 1993**  
**NOTICE UNDER SECTION 15**  
**CY PRES SCHEME RELATING TO THE**  
**PAUL SEALE SCHOLARSHIP**

Section 12(1)(a) of the *Charitable Trusts Act 1993* (**the Act**) permits the Attorney General to establish a cy pres scheme to alter the original purpose of a charitable trust. Section 9(1) permits the application of trust property cy pres where the spirit of the original trust can no longer be implemented.

The Paul Seale Scholarship (**the Scholarship**) was established by a gift to the University of Sydney (**the University**) from the Macintosh Foundation in 2011 for a scholarship for a candidate for the degrees of Bachelor of Medicine and Bachelor of Surgery (**MBBS**) to undertake an Honours project at the University in the field of infectious diseases. As at the time of writing, the Scholarship fund was valued at \$12,295.

Under the terms of the gift, the Scholarship was to be awarded to an Honours student undertaking the MBBS at the University on the basis of the candidate's academic record and the quality of the proposed research project. In 2014, the University replaced the undergraduate MBBS with a postgraduate degree of Doctor of Medicine. The last cohort of MBBS was in 2013. As the undergraduate MBBS (including the Honours program) is no longer offered at the University, the original terms of the trust have become impossible to fulfil.

The University holds the gift from the Macintosh Foundation on an express trust for the purpose of awarding a scholarship. Trusts for the establishment and award of scholarships for students at educational institutions or for study in a recognised field, such as medicine, are charitable as they fall within the charitable head of advancement of education.

As the University now offers medicine at a postgraduate level, a cy pres scheme is required to remove the requirement that the candidate must be undertaking an Honours project in the MBBS. The proposed scheme would instead require that the candidate be studying medicine to undertake a research project in the field of infectious diseases at the University. The condition that the Scholarship would be awarded to a candidate or candidates on the basis of the candidate's academic record and the quality of the proposed project would continue.

Given the Scholarship was named after Professor Paul Seale, who graduated from the University as a medical student and later held roles as Head of the Department of Pharmacology and Professor Pharmacology, it appears that Macintosh Foundation intended that the gift be for the benefit of medical students at the University, rather than any other University. Further, as the gift was expressly made for the benefit of medical students undertaking research projects in the field of infectious diseases, the proposed new trust purpose is sufficiently close to the original purpose of the trust.

In these circumstances, the Solicitor General, as the Attorney General's delegate, has approved the establishment of a cy pres scheme to alter the original purposes of the charitable trust so as to enable the Scholarship to be awarded annually to a student studying medicine to undertake a research project in the field of infectious diseases at the University.

## Anti-Discrimination Act 1977

## Anti-Discrimination Act 1977

### EXEMPTION ORDER

Under the provisions of section 126 of the *Anti-Discrimination Act 1977* (NSW), an exemption is given from sections 31A and 51 of the *Anti-Discrimination Act 1977* (NSW) to Macquarie University (Macquarie Business School) to offer, advertise and facilitate scholarships, prizes and mentorships for individuals who identify as women in the fields of: accounting, actuarial studies, economics, business management and marketing, and finance.

This exemption will remain in force for 10 years.

**CHARITABLE TRUSTS ACT 1993**  
**NOTICE UNDER SECTION 15**  
**CY PRES SCHEME RELATING TO THE**  
**HERBERT JOHN WILKINSON MEMORIAL PRIZE**

Section 12(1)(a) of the *Charitable Trusts Act 1993* (**the Act**) permits the Attorney General to establish a cy pres scheme to alter the original purpose of a charitable trust. Section 9(1) permits the application of trust property cy pres where the spirit of the original trust can no longer be implemented.

The Herbert John Wilkinson Memorial Prize (**the Prize**) was established in 1963 by a bequest contained in the Will of the late Herbert John Wilkinson (**Mr Wilkinson**). The Will provides for a bequest to the University of Sydney (**the University**) for the establishment of an annual prize for undergraduate medical students studying anatomy. As at 25 September 2022, the Prize fund was valued at \$122,881.

The University holds the bequest from Mr Wilkinson on an express trust for the purpose of awarding a prize for undergraduate students of medicine studying anatomy. Trusts for the establishment and award of prizes or scholarships for students at educational institutions or for study in a recognised field, such as medicine, are charitable as they fall within the charitable head of advancement of education.

Under the terms of the trust, the Prize is to be awarded annually to the undergraduate medical student who attains the highest examination results in the courses of anatomy required by the Department of Anatomy at the University. The Will provides that in the event of an equality of marks in those courses, the Faculty of Medicine will determine who will receive the prize.

In 2014, the University replaced the undergraduate Bachelor of Medicine and Bachelor of Surgery (**MBBS**) with a postgraduate degree of Doctor of Medicine. The last cohort of MBBS was in 2013. As the undergraduate MBBS is no longer offered at the University. The Faculty of Medicine is now referred to as the Faculty of Medicine and Health, which was established in 2018 following merger of the schools of medicine, dentistry, medical sciences, nursing, pharmacy and public health. Further, anatomy is no longer taught as a discrete subject, but rather across different subjects across different year levels of a student's course, so it is no longer possible to award the Prize on the basis of examination results in the requisite courses. Accordingly, the original terms of the trust have become impossible to fulfil.

A cy pres scheme is required to remove the requirements that the Prize be awarded to an undergraduate student who attains the highest examination results in the required courses in anatomy, or as determined by the Faculty of Medicine where there is an equality of marks. The proposed scheme would instead require that the Prize be awarded annually to a medical student for proficiency in the study of anatomy. The University is able to determine the candidate who has shown proficiency in that area through application of its internal policy.

In these circumstances, the Solicitor General, as the Attorney General's delegate, has approved the establishment of a cy pres scheme whereby the requirement that the Prize must be awarded to an undergraduate medical student who attains the highest examination results in the required courses in anatomy be removed and replaced with the requirement that the Prize be awarded annually to a medical student for proficiency in the study of anatomy.

## CHARITABLE TRUSTS ACT 1993

### NOTICE UNDER SECTION 15

#### CY PRES SCHEME RELATING TO THE DR CHARLOTTE LAST PRIZE

Section 12(1)(a) of the *Charitable Trusts Act 1993* (**the Act**) permits the Attorney General to establish a cy pres scheme to alter the original purpose of a charitable trust. Section 9(1) permits the application of trust property cy pres where the spirit of the original trust can no longer be implemented.

This submission considers the Dr Charlotte Last Memorial Prize, which is currently valued at \$184,069, which was established in 1997 by an *inter vivos* gift from Minivolt Pty Ltd (**Minivolt**) to the University of Sydney (**the University**).

The terms require a candidate to be undertaking a Bachelor of Medicine and Bachelor of Surgery (**MBBS**) and a research project in either Paediatrics, Obstetrics and Gynaecology, Surgery or Neurosciences with a preference given to projects relating to premature births, orthopedic surgery and epilepsy. However, in 2014 the undergraduate degree of MBBS was replaced with the postgraduate degree of Doctor of Medicine. Therefore, the original terms of the trust have become impossible to fulfil.

The University holds the gift from Minivolt on an express trust for the purpose of awarding a scholarship. Trusts for the establishment and award of prizes and scholarships for students at educational institutions or for study in a recognised field, such as medicine, are charitable.

A cy pres scheme is required to remove the requirement that a candidate must be enrolled in a MBBS and replaced with the requirement that the candidate be undertaking a postgraduate degree and a research project in either Paediatrics, Obstetrics & Gynaecology, Surgery or Neurosciences, provided that the project is of sufficient merit. Preference will be given to projects relating to premature births, orthopaedic surgery and epilepsy.

In these circumstances, the Solicitor General, as the Attorney General's delegate has approved the establishment of a cy pres scheme whereby the requirement that the candidate for the Prize must be undertaking a MBBS at the University is removed and replaced with the requirement that a candidate of the Scholarship is undertaking a research project in either Paediatrics, Obstetrics & Gynaecology, Surgery or Neurosciences.
