# **EXEMPTION ORDER**

Under the provisions of section 126 of the *Anti-Discrimination Act* 1977 (NSW), an exemption is given from sections 8 and 51 of the *Anti-Discrimination Act* 1977 (NSW) to Bega Valley Shire Council to designate, advertise and recruit up to 5 positions for Aboriginal and Torres Strait Islander persons only.
