Water ski races will be conducted on the navigable waters of Hawkesbury River at Cliftonville involving the use of power vessels, persons being towed at speed using tow lines and the possibility of persons in the water from time to time, presenting a significant potential hazard to other waterway users.

An **EXCLUSION ZONE** is specified during the event, which will be monitored and maintained by control vessels.

Unauthorised vessels and persons are strictly prohibited from entering the Exclusion Zone.

Blowering Dam, Tumut

8:00am to 4:00pm on the following dates:

- Saturday 9 September 2023
- Sunday 10 September 2023

Detail

Trials involving the use of a high-speed vessel powered by a jet engine will be conducted on the waters of Blowering Dam at varying times on the days specified above. The jet powered vessel will be operating at very high speed and will present a significant potential hazard to other waterway users. There will be support and official vessels present to manage the trials.

An **EXCLUSION ZONE** is specified during the event, which will comprise of the entirety of Blowering Dam, and will be monitored and maintained by control and Maritime vessels.

At varying times between trials, such as when the jet powered vessel is not being operated, Maritime officers on-site may lift the Exclusion Zone to allow boaters to use the waterway for periods of time.

Other than during these interim periods, unauthorised vessels and persons are strictly prohibited from entering the Exclusion Zone.

Penalties may apply (section 12(5) - Marine Safety Act 1998).
