# ORDER

#### Restoration of Drug Authority

In accordance with the provisions of clause 175(1) of the *Poisons and Therapeutic Goods Regulation 2008*, the Order that took effect on and from 24 January 2022, on **Dr Lei Min CHEN (MED0001167211)** of SYDNEY NSW 2000, prohibiting him as a medical practitioner from supplying or having possession of drugs of addiction as authorised by clause 101 of the Regulation, and issuing a prescription for a drug of addiction as authorised by clause 77 of the Regulation, shall cease to operate on and from 8 September 2023.

#### Withdrawal of Drug Authority
