#### PROTECTION OF THE ENVIRONMENT OPERATIONS (GENERAL) REGULATION 2022

Order granting exemption under section 150

#### Discharge of per-and poly-fluoroalkyl substances (PFAS) firefighting foams

#### **Background**

A previous exemption granted under Section 150 of the *Protection of the Environment Operations* (General) Regulation 2022 (Regulation) is due to expire on 26 September 2023.

#### Introduction

This current exemption revokes and replaces the exemption made under Section 150 of the Regulation (Gazette Reference no2022-1760) published 9 September 2022.

#### This exemption:

- **1.1.** is issued by the Environment Protection Authority (**EPA**) under section 150 of the *Protection* of the Environment Operations (General) Regulation 2022 (**Regulation**),
- 1.2. exempts, subject to the conditions of this Order, the persons listed in Column 1 of the table in Schedule 1 to this Order from the prohibition under section 148 of the Regulation on the discharge of prescribed long-chain PFAS firefighting foam at the premises listed in Column 2 of the table in Schedule 1 to this Order, but only to prevent, extinguish or attempt to extinguish a fire that is:
  - a) a catastrophic fire, or
  - b) a fire that has the potential to be a catastrophic fire.

#### 2. Conditions

- **2.1.** This exemption applies to the discharge of prescribed long-chain PFAS firefighting foam to prevent, extinguish or attempt to extinguish a catastrophic fire or a fire that has the potential to be a catastrophic fire.
- **2.2.** The persons to which this Order applies must provide the EPA with a plan to phase out the use of prescribed long-chain PFAS firefighting foam at the person's premises.
- **2.3.** The persons listed in this Order must demonstrate, to the satisfaction of the EPA, the implementation of their plan to phase out the use of prescribed long-chain PFAS firefighting foam.
- **2.4.** This order has effect from 26 September 2023 until 26 September 2024 unless otherwise varied or revoked by the EPA.

#### **Definitions**

Terms in this Order have the same meaning as in the Regulation.
