MENTAL HEALTH ACT 2007 Section 109 Declaration of Mental Health Facility

- I, DR BRENDAN FLYNN, Executive Director, Mental Health Branch, acting under delegation of the Secretary, NSW Ministry of Health, and pursuant to section 109 of the *Mental Health Act 2007*, and section 43 of the *Interpretation Act 1987*; DO HEREBY:
- (a) VARY the Order made pursuant to section 109 of the Mental Health Act 2007, published in the NSW Government Gazette No. 166 of 13 November 2009, page 5675-5676, declaring certain Emergency Departments to be declared mental health facilities, by removing the reference to 'the Emergency Department of Gosford Hospital, located on the Gosford Hospital Campus at Holden Street, Gosford NSW 2250'; and
- (b) DECLARE the following premises of Gosford Hospital to be a declared mental health facility for the purposes of the *Mental Health Act 2007*:
 - Emergency Department of Gosford Hospital, located in Building J, Gosford Hospital Campus, 75 Holden Street, Gosford NSW 2250; and
- (c) DECLARE this facility to be designated as a "mental health emergency assessment class" facility; and
- (d) RESTRICT this facility to the provision of acute assessment functions, where a patient can be held in anticipation of discharge should their clinical condition resolve rapidly, or transferred to a declared mental health facility of the "mental health assessment and inpatient treatment" class if required, in accordance with all provisions of the *Mental Health Act 2007*, with the exception of:
- i. Chapter 2;
- ii. Division 3 of Part 2 of Chapter 3;
- iii. Division 1 of Part 3 of Chapter 3;
- iv. Sections 57 and 58 of Division 2 of Part 3 of Chapter 3.

MENTAL HEALTH ACT 2007 Section 109 Declaration of Mental Health Facility

- I, DR BRENDAN FLYNN, Executive Director, Mental Health Branch, acting under delegation of the Secretary, NSW Ministry of Health, and pursuant to section 109 of the *Mental Health Act 2007*, and section 43 of the *Interpretation Act 1987*; DO HEREBY:
- (a) VARY the Order made pursuant to section 109 of the *Mental Health Act 2007*, published in the NSW Government Gazette No. 166 of 13 November 2009, page 5675-5676, declaring certain Emergency Departments to be declared mental health facilities, by removing the reference to 'the Emergency Department of Wyong Hospital, located on the Wyong Hospital Campus on Pacific Highway Hamlyn Terrace NSW 2259'; and
- (b) DECLARE the following premises of Wyong Hospital to be a declared mental health facility for the purposes of the *Mental Health Act 2007*:

Emergency Department of Wyong Hospital, located in Building H, Wyong Hospital Campus, 664 Pacific Highway, Hamlyn Terrace NSW 2259; and

- (c) DECLARE this facility to be designated as a "mental health emergency assessment class" facility; and
- (d) RESTRICT this facility to the provision of acute assessment functions, where a patient can be held in anticipation of discharge should their clinical condition resolve rapidly, or transferred to a declared mental health facility of the "mental health assessment and inpatient treatment" class if required, in accordance with all provisions of the *Mental Health Act 2007*, with the exception of:
- i. Chapter 2:
- ii. Division 3 of Part 2 of Chapter 3;
- iii. Division 1 of Part 3 of Chapter 3;
- iv. Sections 57 and 58 of Division 2 of Part 3 of Chapter 3.

MENTAL HEALTH ACT 2007 Section 109 Declaration of Mental Health Facility

- I, DR BRENDAN FLYNN, Executive Director, Mental Health Branch, acting under delegation from the Secretary, NSW Ministry of Health, and pursuant to section 109 of the *Mental Health Act 2007*, and section 43 of the *Interpretation Act 1987*, DO HEREBY:
- (a) REVOKE the Order published in the NSW Government Gazette number 339 of 23 July 2021 (n2021-1569), declaring certain premises at Wyong Hospital to be a declared mental health facility for the purposes of section 109 of the *Mental Health Act 2007*; and
- (b) DECLARE the following premises of Wyong Hospital, 654 Pacific Highway, Hamlyn Terrace NSW 2259 to be a declared mental health facility for the purposes of section 109 of the *Mental Health Act 2007*:
 - Miri Miri Older People's Unit, located within the Wyong Mental Health Centre, Building F, Harry Moore Drive, Wyong Hospital campus;
 - Wyong High Dependency Unit, located within the Wyong Mental Health Centre, Building F, Harry Moore Drive, Wyong Hospital campus;
 - Wyong General Acute Unit, located within the Wyong Mental Health Centre, Building F, Harry Moore Drive, Wyong Hospital campus;
 - Wyong Hospital Psychiatric Emergency Care Centre, located within the Emergency Department, Level 2, Building H, Wyong Hospital campus; and
- (c) DECLARE this facility to be designated as a "mental health assessment and inpatient treatment class" facility.
