#### **Revocation of Interim Heritage Order No 163**

#### **INTERIM HERITAGE ORDER NO. 167**

#### The Corner House 364 Edgecliff Road, Woollahra

In pursuance of Section 24 of the *Heritage Act* 1977 (NSW), I, the Minister for Environment and Heritage, do, by this my order:

- (i) make an interim heritage order in respect of the item of the environmental heritage specified or described in Schedule 'A'; and
- (ii) declare that the interim heritage order shall apply to the curtilage or site of such item, being the land described in Schedule 'B'.

The Order takes effect from the date of gazettal and remains in force until 4 March 2023 unless otherwise revoked.
