PROCLAMATION

, Lieutenant-Governor

I, the Honourable Andrew Scott Bell, Lieutenant-Governor of the State of New South Wales, with the advice of the Executive Council and in pursuance of section 218B of the *Local Government Act 1993*, do, by this my Proclamation, alter the boundaries of the areas of-

- (a) Liverpool Plains Shire as described by Proclamation in Government Gazette No. 49 of 19 April 2013, and
- (b) Upper Hunter Shire as described by Proclamation in Government Gazette No. 102 of 6 September 2019.

by transferring the land described in Schedule A from the Upper Hunter Shire local government area to the Liverpool Plains Shire local government area so that the boundaries of the area of-

- (a) Liverpool Pool Plains Shire are the boundaries shown on the map kept in the register of public surveys and having the identifier number PP5252, and
- (b) Upper Hunter Shire are the boundaries shown on the map kept in the register of public surveys and having the identifier number PP5253.

I also make the provision in Schedule B for the apportionment of rates and charges between the said councils.

In this Proclamation *register of public surveys* means the register of that name kept under the *Surveying and Spatial Information Act 2002*.

- 3) In the event that the General Managers of Liverpool Plains Shire Council and Upper Hunter Shire Council cannot come to a negotiated agreement on the matter of rates and charges, the Councils shall request that the Minister for Local Government make a determination on that matter.
