#### MARINE NOTICE

#### Section 12(2)

#### REGULATION OF VESSELS – EXCLUSION ZONE & SPECIAL RESTRICTIONS

#### Location

Hunter River, Raymond Terrace – entire width of the river downstream from the Fitzgerald Bridge, between the prolongations of Bourke Street and Swan Street.

#### **Duration**

8.30am to 5.30pm on the following dates:

- Saturday 21 October 2023
- Sunday 22 October 2023

#### **Detail**

Competitive powerboat races will be conducted on the navigable waters of Hunter River, Raymond Terrace as specified above. The event will involve the use of high-speed power vessels, presenting a significant potential hazard to other waterway users.

An **EXCLUSION ZONE** is specified during the event, which will be indicated by control vessels stationed on the boundary.

Unauthorised vessels and persons are strictly prohibited from entering the Exclusion Zone.

#### **Transit lane**

Provision may be made (where necessary) for a control vessel to authorise local vessel traffic to pass safely through the Exclusion Zone via a 'transit lane'.

### **Special Restrictions**

Pursuant to section 12(3) of the Act, vessels using the transit lane must do so at a speed not exceeding 4 knots and must produce minimal wash.

Penalties may apply (section 12(5) - Marine Safety Act 1998).

#### MARINE NOTICE

#### Section 12(2)

#### **REGULATION OF VESSELS - EXCLUSION ZONE**

#### Location

Hawkesbury River – at the Peats Ferry Bridge (Old Pacific Highway Bridge) between Kangaroo Point in the south, and Mooney Mooney in the north.

#### **Duration**

Friday 20 October 2023 until Tuesday 3 June 2025.

#### **Detail**

Rehabilitation works will be conducted to spans 2 and 3 of the Peats Ferry Bridge as specified above, presenting a navigational hazard to waterway users.

An **EXCLUSION ZONE** is specified between the above dates and will be marked by lit yellow buoys and channel blocked shapes and lights.

Unauthorised vessels and persons are strictly prohibited from entering the Exclusion Zone.

Vessel operators are also advised that the navigable channel (usually Span 2 of M1 bridge) will be relocated to Span 5 at various times throughout the works, and to pay close attention to marks indicating closed and open channels indicated by aids to navigation as mentioned above.

Penalties may apply (section 12(5) - Marine Safety Act 1998).
