#### Exemption from Mining Act 1992 Section 6 (Opal Puddling) Order 2023

I, TONY LINNANE, Acting Executive Director Assessments and Systems, Mining, Exploration and Geoscience within the Department of Regional NSW, with the delegated authority of the Minister, pursuant to clause 11 of the Mining Regulation 2016 (Regulation), exempt the class of persons specified in Column 1 of Schedule 1 from the operation of section 6 of the *Mining Act 1992* (Act) with respect to the carrying out of the classes of ancillary mining activities specified in Column 2 of Schedule 1.

This Order takes effect on the day that it is published in the *New South Wales Government Gazette* and will cease to have effect 1 year after the day this Order is published in the Gazette unless it is repealed before that date.

In this Order, opal puddling means the processing of opal bearing material (opal dirt) for the purpose of separating clay or silt fraction from opal.

Unless otherwise stated, words and expressions that are defined in the Act or the Regulation have the same meaning in this Order.

Schedule 1

#### Exemption from Mining Act 1992 Section 163C(1) (opal prospecting reporting) Order 2023

I, TONY LINNANE, Acting Executive Director Assessments and Systems, Mining, Exploration and Geoscience within the Department of Regional NSW, with the delegated authority of the Secretary of the Department of Regional NSW, pursuant to clause 68(1) of the Mining Regulation 2016 (Regulation), exempt the following class of persons from the requirement to prepare and lodge a report for the purposes of section 163C(1) of the Mining Act 1992 (Act):

1. Holder of an opal prospecting licence in an opal prospecting area within the Lightning Ridge Mineral Claims district.

This Order takes effect on the day that it is published in the *New South Wales Government Gazette* and will cease to have effect 1 year after the day this Order is published in the Gazette unless it is repealed before that date.
