Lake Albert, Wagga Wagga

Duration

9:00am to 6:00pm on the following dates:

- Saturday 18 November 2023
- Sunday 19 November 2023

Detail

Powerboat demonstrations will be conducted on the navigable waters of Lake Albert as specified above. This will involve the use of high-speed power vessels which will be active in the area, presenting a significant potential hazard to other waterway users.

An **EXCLUSION ZONE** is specified during the event which will comprise the entirety of Lake Albert, which will effectively close the Lake to all other vessel users between the above times for this event.

Unauthorised vessels and persons are strictly prohibited from entering the Exclusion Zone which will be monitored by event officials and control vessels.

1 Name of Order

This Order is the Ministerial (Toll Operator Declaration) Order 2023.

2 Commencement

This Order has effect on and from the date of publication in the NSW Government Gazette.

3 Repeal

This Order revokes and replaces the *Ministerial (Toll Operator Declaration)*Order 2019, published in Government Gazette No.179 on 20 December 2019 at page 5749

4 Effect

This Order remains in force until it revoked or replaced by Order published in the Gazette.

5 Order

For the purposes of the definition of 'toll operator' in the Dictionary to the *Roads Act 1993* each of the following persons are declared to be the toll operator in respect of the corresponding tollway:

Explanatory Note

Blowering Dam, Tumut

Duration

8:00am to 4:00pm on the following dates:

- Saturday 18 November 2023
- Sunday 19 November 2023

Detail

Trials involving the use of a high-speed vessel powered by a jet engine will be conducted on the waters of Blowering Dam as specified above. The jet powered vessel will be operating at very high speed and will present a significant potential hazard to other waterway users. There will be support and official vessels present to manage the trials.

An **EXCLUSION ZONE** is specified during the event, which will comprise of the entirety of Blowering Dam, and will be patrolled by Maritime vessels.

At varying times between trials, such as when the jet powered vessel is not being operated, Maritime officers on-site may lift the Exclusion Zone to allow boaters to use the waterway for periods of time.

Other than during these interim periods, unauthorised vessels and persons are strictly prohibited from entering the Exclusion Zone.

Penalties may apply (section 12(5) - Marine Safety Act 1998).

An EXCLUSION ZONE is specified during the event, which will be monitored by control vessels stationed on the perimeter and patrolled by Maritime vessels.

Unauthorised vessels and persons are strictly prohibited from entering the Exclusion Zone.



Location

Wallis Lake, Forster – Elizabeth Reserve, Forster Keys.

Duration

8.00am to 5.00pm on the following dates:

- Saturday 18 November 2023
- Sunday 19 November 2023

Detail

Dragon boat races will be conducted on the navigable waters of Wallis Lake as specified above.

An **EXCLUSION ZONE** is specified during the event which will be marked by buoys and the presence of control vessels on the boundary.

Unauthorised vessels and persons are strictly prohibited from entering the Exclusion Zone.

Transit lane

Provision may be made (where necessary) for control vessels to authorise local vessel traffic to pass safely through the zone via a 'transit lane'.

Special Restrictions

Pursuant to section 12(3) of the Act, vessels using the transit lane must produce minimal wash.

Penalties may apply (Section 12(5) - Marine Safety Act 1998).

Location

Murray River – entire width of the River at the following locations:

- Monday 20 November 2023: from the Mulwala Weir near the 1986km river marker, downstream to the township of Tocumwal, near 1886km river marker.
- Tuesday 21 November 2023: from the township of Tocumwal near the 1886km river marker, downstream to Picnic Point, near the 1790km river marker.
- Wednesday 22 November 2023: from Picnic Point, near the 1790km river marker, downstream to the Moama Beach, Moama, near the 1712km river marker.
- Thursday 23 November 2023: from the Moama Beach, Moama, near the 1712km river marker, downstream to Torrumbarry Headworks Boat ramp near the 1648km river marker.
- Friday 24 November 2023: from Brereton Road, Gunbower near the 1622km river marker, downstream to Apex Park, Koondrook near the 1524km river marker.

6.30am to 6.00pm on the following days:

Detail

A canoe and kayak event will be conducted on the waters of the Murray River as detailed above.

Due to the risk to safe navigation and the nature and number of participating vessels, a Regulated Area will be created at the above times within which **Special Restrictions** will apply to all powered vessels. The Regulated Area will comprise the entire width of the River and will extend 200 metres ahead and 200 metres behind the competing vessels, as indicated by the presence of official vessels. The Regulated Area will surround and move with the competing vessels.

The start of the Regulated Area will be indicated by an official vessel positioned alongside the leading competitor, displaying two red flags. The end of the Regulated Area will be marked by an official vessel positioned alongside the final competitor, displaying a single green flag.

Special Restrictions

Pursuant to section 12(3) of the *Marine Safety Act 1998*, **powered vessels** operating in the Regulated Area:

- Must not exceed the maximum speed limit of 4 knots, and
- Must produce minimal wash.

Penalties may apply (section 12(5) - Marine Safety Act 1998).
